requirement that the remuneration committee must be comprising a majority of independent non-executive directors under Rule 5.34 of the GEM Listing Rules. The Company also fails to meet the requirement that the nomination committee must be chaired by the chairman of the board or an independent non-executive director and comprising a majority of independent non-executive directors under Rule 5.36A of the GEM Listing Rules.

To comply with Rules 5.05(1), 5.05A, 5.28, 5.34 and 5.36A of the GEM Listing Rules, the Company is endeavouring to identify suitable candidates to fill the vacancies of the INEDs, the members of the Audit Committee, the Remuneration Committee and the Nomination Committee and the chairperson of the Nomination Committee as soon as practicable, with the relevant appointment(s) to be made within three months from the date of the resignation of Mr. LAM as required under Rules 5.06, 5.33 and 5.36 of the GEM Listing Rules. The Company will make further announcement(s) as and when appropriate.
