EXTENSION OF LONG STOP DATE IN RELATION TO PLACING OF NEW SHARES UNDER GENERAL MANDATE

Reference is made to the announcement of hmvod Limited (the “**Company**”) dated 28 September 2023 and the supplemental announcement of the Company dated 29 September 2023 in relation to the placing of new shares under general mandate (collectively called the “**Announcements**”). Capitalized terms used herein shall have the same meanings as those defined in the Announcements unless the context otherwise requires.

Pursuant to the Placing Agreement (as amended and supplemental by the supplemental agreement dated 29 September 2023 (the “**First Supplemental Agreement**”)), the Completion of the Placing shall take place on the date on which all the conditions precedent of the Placing (the “**Conditions**”) having been satisfied or waived. If the Conditions have not been fulfilled by 19 October 2023, the Placing Agreement (as amended and supplemental by the First Supplemental Agreement) shall be terminated and of no effect.

As additional time is required for the fulfillment of certain Conditions under the Placing Agreement (as amended and supplemental by the First Supplemental Agreement), the Company and the Placing Agent entered into a supplemental agreement on 18 October 2023 to extend the Long Stop Date to 31 October 2023.

Save as disclosed above, all other terms and conditions of the Placing Agreement (as amended and supplemental by the First Supplemental Agreement) remain unchanged and in full force and effect in all respects.

As the Placing may or may not proceed, Shareholders and potential investors of the Company are reminded to exercise caution when dealing in the securities of the Company.
