Remarks:

Tianjin Binhai Teda Logistics (Group) Corporation Limited (the "Company") has received the formal approval from the China Securities Regulatory Commission on 19 July 2023, as disclosed in the announcement of the Company dated 20 July 2023, and the approval from The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 13 October 2023, as disclosed in the announcement of the Company dated 16 October 2023, of the conversion of all of 256,068,800 unlisted domestic shares of the Company ("Domestic Shares") into H shares of the Company ("H Shares") and their listing thereof on the Stock Exchange. The conversion and listing have been completed, as disclosed in the announcement of the Company dated 26 October 2023.

Immediately before completion of the conversion and listing, the total number of issued shares of the Company was 354,312,000 shares (including 256,068,800 Domestic Shares and 98,243,200 H Shares). Upon completion of the conversion and listing, H Shares increased by 256,068,800 shares, while Domestic Shares decreased by 256,068,800 shares. The total number of issued shares of the Company remains unchanged.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
