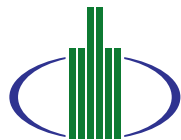

**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 27 OCTOBER 2023**

The Board is pleased to announce that all the resolutions set out in the notice of the AGM dated 25 September 2023 were duly passed by the Shareholders by way of poll at the AGM held on 27 October 2023.

Reference is made to the circular (the “**Circular**”) of WLS Holdings Limited (the “**Company**”) and the notice of annual general meeting (“**AGM**”) of the Company (the “**Notice**”) both dated 25 September 2023. Capitalised terms used in this announcement shall have the same meanings as defined in the Circular unless the context otherwise requires.

POLL RESULTS OF THE AGM

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that all the resolutions set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 27 October 2023. The Company’s branch share registrar in Hong Kong, Union Registrars Limited, was appointed scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the total number of Shares in issue in the Company was 14,367,101,072, which was the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. No Shareholder was entitled to attend and vote only against the resolutions at the AGM and no Shareholder was required to abstain from voting on the resolutions at the AGM.

The following Directors, namely, Mr. Law Man Sang and Mr. Lo Ka Ki attended the AGM in person. The following Directors namely, Mr. So Wang Chun, Edmond, Mr. Yang Haijia, Ms. Wang Lili and Ms. Lam Wai Yu, attended the AGM via real-time communication facilities.
