PROFIT WARNING

This announcement is made by Kwong Man Kee Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the Group’s unaudited consolidated management accounts for the six months ended 30 September 2023 and information currently available to the Board, the Group is expected to record a decrease in the consolidated attributable profit to the owners of the Company of approximately HK\$6 million or about 40% for the six months ended 30 September 2023 as compared with the consolidated attributable profit to the owners of the Company for corresponding period of 2022.

The Board considered that such decline in the consolidated profit for the six months ended 30 September 2023 was mainly attributable to (1) the decrease in revenue due to the postponement of certain contracts by property developers caused by the adverse market conditions; and (2) the cessation of subsidies provided by the Government of Hong Kong Special Administrative Region and the Government of Macau Special Administrative Region under the 2022 Employment Support Scheme and COVID-19 pandemic relief measures, respectively.

The Company is still in the process of finalising its unaudited consolidated management accounts for the six months ended 30 September 2023. The information contained in this announcement is only based on the preliminary assessment by the Board on the unaudited consolidated management accounts of the Group for the six months ended 30 September 2023 and the information available for the time being, which have been neither reviewed by the audit committee of the Company nor audited by the Company’s auditors, and is subject to possible adjustment. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the six months ended 30 September 2023, which is expected to be released on 8 November 2023 in accordance with GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
