On 3 November 2023 and 8 November 2023 (after trading hours), Metropolis Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Factoring Agreement I and the Factoring Agreement II with Customer P respectively, pursuant to which, Metropolis Leasing has agreed to provide accounts receivable factoring facility to Customer P with the factoring principal amount at the aggregate of up to approximately RMB3,500,000 (equivalent to approximately HK\$3,734,130) (of which the Factoring Agreement I accounted for approximately RMB1,000,000 (equivalent to approximately RMB1,000,000 (equivalent to approximately RMB1,066,894) and the Factoring Agreement II accounted for approximately HK\$2,667,236) respectively) for the respective factoring period.

### IMPLICATIONS UNDER THE GEM LISTING RULES

As none of the applicable percentage ratios for the transaction under the Factoring Agreement I calculated in accordance with the GEM Listing Rules exceed 5%, the transaction contemplated under the Factoring Agreement I, on a standalone basis, did not constitute a notifiable transaction for the Company under Chapter 19 of the GEM Listing Rules.

As the Factoring Agreement I and the Factoring Agreement II were entered into with the same customer within a 12-month period, the transaction contemplated under the Factoring Agreement II shall be aggregated with the transaction contemplated under the Factoring Agreement I under Rule 19.22 of the GEM Listing Rules.

On 3 November 2023 and 8 November 2023 (after trading hours), Metropolis Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Factoring Agreement I and the Factoring Agreement II with Customer P respectively, pursuant to which, Metropolis Leasing has agreed to provide accounts receivable factoring facility to Customer P with the factoring principal amount at the aggregate of up to approximately RMB3,500,000 (equivalent to approximately HK\$3,734,130) (of which the Factoring Agreement I accounted for approximately RMB1,000,000 (equivalent to approximately HK\$1,066,894) and the Factoring Agreement II accounted for approximately RMB2,500,000 (equivalent to approximately HK\$2,667,236) respectively) for the respective factoring period.

In addition, in the event Metropolis Leasing suffered other losses as a result of Customer P's breach of contract, Metropolis Leasing is also entitled to liquidated damages representing 5% of the factoring principal amount.

# **REASONS FOR AND BENEFITS OF THE TRANSACTIONS UNDER THE FACTORING AGREEMENTS**

The principal business of the Group is the provision of finance lease, finance leasing advisory and factoring services to its customers in the PRC. The Group started to provide factoring services to its customers from 2020 which enables the Group to generate additional revenue and cash flow stream to the Group. It is expected that the Factoring Agreements will enable the Group to earn a maximum aggregate income of approximately RMB525,000 (equivalent to approximately HK\$560,119).

The terms of the Factoring Agreements were agreed between the parties after arm's length negotiations and are on normal commercial terms. The provision of factoring principal amount to Customer P under the Factoring Agreements will mainly be financed by internal resources of the Group.

Given that the Factoring Agreements were entered into in the ordinary and usual course of business of the Group and on normal commercial terms, the Directors are of the view that the terms of the Factoring Agreements are fair and reasonable and are in the interest of the Company and the shareholders of the Company as a whole.

Metropolis Leasing is an indirect wholly-owned subsidiary of the Company. The Group, including Metropolis Leasing, is primarily engaged in the provision of finance lease, finance leasing advisory and factoring services to its customers in the PRC.

### **INFORMATION ABOUT CUSTOMER P**

Customer P is a company established in the PRC with limited liability which is primarily engaged in the sales of household appliances, sanitary ware, kitchen supplies and edible agricultural products. To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, Customer P is owned as to 90% by Xing Biyu\* (邢碧 $\overline{E}$ ) and 10% by Xing Bilian\* (邢筆連), each being a PRC citizen.

To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, each of Customers P and its ultimate beneficial owner is an Independent Third Party and, save as disclosed in this announcement, they have no past or present relationships (formal or informal, business or otherwise, implied or explicit) with the Company or its connected persons.
