POSITIVE PROFIT ALERT

This announcement is made by Amuse Group Holding Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby informs the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the Board’s preliminary review of the unaudited consolidated management accounts (the “**Management Accounts**”) of the Company for the period ended 30 September 2023 (the “**Period**”) which have not been audited by the auditors of the Company nor reviewed by the audit committee of the Company, it is expected that the Group may record a loss of not more than HK\$1.0 million attributable to owners of the Company for the Period, as compared with the loss of approximately HK\$3.6 million for the period ended 30 September 2022 (the “**Corresponding Period**”). Based on the information available to the Company immediately preceding the publication of this announcement, the Board considers that the decrease of loss during the Period was mainly attributable to (i) revenue from the distribution of imported toys has increased by approximately 14.8%; (ii) the newly acquired wholly-own subsidiary company has contributed the revenue of agency services related to engineering projects with substantially low at cost.

The information contained in this announcement is only based on the Board’s assessment of the information currently available to the Company and the Management Accounts. The Company is still in the process of finalising such accounts. The Company expects to publish an announcement on the interim result of the Group for the Period on 14 November 2023.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
