Summary

- Revenue for the nine months ended 30 September 2023 amounted to approximately HK\$143.61 million (nine months ended 30 September 2022: approximately HK\$207.71 million), representing a decrease of approximately 30.86% as compared with that for the corresponding period in 2022.
- Loss attributable to owners of the Company for the nine months ended 30 September 2023 amounted to approximately HK\$6.03 million (Profit attributable to owners of the Company for nine months ended 30 September 2022: approximately HK\$2.64 million).
- Basic loss per share for the nine months ended 30 September 2023 amounted to approximately HK3.66 cent (Basic earning per share for nine months ended 30 September 2022: HK1.60 cent).

1. CORPORATE INFORMATION

The Company was incorporated in the Cayman Islands on 12 June 2017 as an exempted company with limited liability under the Companies Law, Cap.22 (Law 3 of 1961 as consolidated and revised) of the Cayman Islands. The registered office of the Company is located at Cricket Square, Hutchins Drive PO Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is located at Units 3, 5 and 6, 15th Floor, Tower One, Ever Gain Plaza, No. 88 Container Port Road, Kwai Chung, New Territories, Hong Kong. Its ultimate holding company and immediate holding company is Million Easy Enterprises Limited, a company incorporated in the British Virgin Islands.

The Company is an investment holding company and its subsidiaries are principally engaged in design and development, manufacturing and distribution of watch products on original design manufacturing ("**ODM**") basis for watch manufacturers, brand owners and watch importers across the global.

The shares of the Company have been listed on the GEM of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") since 12 July 2018 (the "**Listing Date**").

The unaudited condensed consolidated financial statements are presented in ("HK\$" or "HKD") which is also the functional currency of the Company and its subsidiaries. All values are rounded to the nearest thousand ("HK\$'000"), except where otherwise indicated.

2. BASIS OF PREPARATION AND ACCOUNTING POLICIES

This unaudited condensed consolidated quarterly financial statements for the nine months ended 30 September 2023 are prepared in accordance with Hong Kong Financial Reporting Standard ("HKFRSs") which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards and interpretations issued by the Hong Kong Institutes of Certified Public Accountants ("HKICPA"). The unaudited condensed consolidated financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the GEM Listing Rules.

This quarterly report does not include all the notes of the type normally included in an annual financial report. Accordingly, this quarterly report is to be read in conjunction with the audited financial statements of the Group for the year ended 31 December 2022 (the "2022 Financial Statements").

The accounting policies adopted are consistent with those of the financial statement for the year ended 31 December 2022, as described in the Accountant's Report. The adoption of the new and revised HKFRSs that are relevant to the Group and effective from the current period had no significant effects on the results and financial position of the Group.

3. REVENUE AND SEGMENT INFORMATION

Information reported to the chief executive officer of the Company, being the chief operating decision makers ("CODMs") for the purpose of resource allocation and assessment of segment performance focuses on types of goods or services delivered or provided. The Group currently operates in the manufacturing and trading business of watches. A single management team reports to the CODMs who comprehensively manages the entire business. Accordingly, the Group does not have separate reportable segments.

Pursuant to the rules and regulations of the Cayman Islands and the British Virgin Islands (the "**BVI**"), the Group is not subject to any income tax in the Cayman Islands and the BVI.

The Group is subjected to Hong Kong Profits Tax at a rate of 16.5% (2022: 16.5%) for the nine months ended 30 September 2023.

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "**Bill**") which introduces the two-tiered profits tax rates regime. The Bill was signed into law on 28 March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%.

One of the subsidiaries of the Company is subject to Hong Kong Profits Tax at the rate of 8.25% for the first HK\$2 million of estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million. Other subsidiaries of the Company are subjected to Hong Kong Profits Tax at the rate of 16.5% for the nine months ended 30 September 2023 and 2022.

7. DIVIDEND

The Board decided not to declare any dividend for the nine months ended 30 September 2023 (2022: Nil).

8. (LOSS)/EARNING PER SHARE

The calculation of loss per share for the nine months ended 30 September 2023 and 30 September 2022 are based on the loss for the period attributable to equity owners of the Company of approximately HK\$6.03 million and profit for the period attributable to equity owners of the Company of approximately HK\$2.64 million respectively.

Diluted earnings per share were same as the basic loss per share as there were no potential dilutive ordinary shares in existence during the period.

BUSINESS REVIEW

Hanvey Group Holdings Limited (the "Company"), and its subsidiaries (collectively refer to as the "Group") are principally engaged in the design and development, manufacturing and distribution of watch products on original design manufacturing basis for watch manufacturers, brand owners and watch importers across the globe.

The Group derives revenue mainly from the sale of: (i) finished watches, (ii) semi-knocked-down kit, and (iii) watch parts.

For the nine months ended 30 September 2023 (the "**Period**"), the Group's revenue amounted to approximately HK\$143.61 million, decreased by approximately 30.86% when compared with that for the corresponding period of 2022.

The Hong Kong Trade Development Council ("**HKTDC**") used to conduct a survey every quarter, which involves interviewing 500 local exporters from six major industries that include machinery, electronics, jewellery, watches and clocks, toys and clothing to gauge their business confidence on near-term export prospects. According to the HKTDC's research entitled: "**HKTDC Export Index 3Q23: Export Sentiment Softens from Two-year High**" dated 27 September 2023, the HKTDC Export Index (the "**Index**") decreased by 7.3 points to 40.5 in the third quarter of 2023 ("**3Q23**"), after reaching a two-year high of 47.8 in the second quarter of 2023 ("**2Q23**"), mainly due to weakening global demand and continued geopolitical tensions. Timepieces saw the most substantial drop, falling by 15.9 points from 48.8 in the 2Q23 to 32.9 in the 3Q23.

Relatively speaking, Hong Kong exporters are more optimistic about the Asian market. ASEAN performed best with a sub-index of 41.6.

Economic risks remain the top concern. Almost half of the respondents (48.6%) saw economic slowdowns or recession risks in overseas markets as the biggest challenge, followed by rising geopolitical tensions (17.9%) and a lower-than-expected boost from the mainland's economic recovery (16.5%).

With the economic gradually recovering from the COVID-19 pandemic, the Group will adopt a prudent approach, and continue exercising stringent control over operating costs, aiming to enhance operating efficiency and improve profitability.

PROSPECTS

Looking ahead, the business environment in overseas markets remains uncertain, the risk of an economic slowdown or recession in overseas markets is the biggest challenge to the export performance in the next few months.

The equity market is likely to remain volatile because of the US Federal Reserve continues to raise interest rates, and the cost of capital has risen, which has caused unprecedented difficulties in business operations. Taking into consideration the challenges faced by the Group, the Group will closely observe the market.

For overseas markets, economic growth in Europe and the United States is projected to slow down due to the negative market outlook under high inflation. However, in the Southeast Asian market that we focus on, there is still a huge market demand of automatic mechanical watch and quartz watch. The Group will closely observe the market trend and provide designs that suit the customers and market needs.

We intend to continue to focus on the core business, take efforts in strengthening our product design and developing capability to maximise the long term returns of the shareholders of the Company.

FINANCIAL REVIEW

For the nine months ended 30 September 2023 (the "**Period**"), the Group's revenue amounted to approximately HK\$143.61 million, represents a decrease of approximately 30.86% when compared with that for the same period in 2022, mainly due to the ongoing uncertainty across the global market. The selling and distribution expenses for the Period remain the similar level as compared with that for the same period in 2022. The administrative expenses decreased by approximately HK\$7.2 million or approximately 16.61% from approximately HK\$43.36 million for the nine months ended 30 September 2022 to approximately HK\$36.16 million for the Period. The decrease was mainly due to the decrease in staff salaries. The finance costs increased by approximately HK\$1.57 million or approximately 34.73% from approximately HK\$4.52 million for the nine months ended 30 September 2022 to approximately HK\$6.09 million for the Period. The increase was mainly due the rise in bank interest rates.

DIVIDENDS

The Board decided not to declare any dividend for the Period.

CAPITAL STRUCTURE

There has been no change in the Company's capital structure during the Period. The capital structure of the Group comprises of issued share capital and reserves. The Directors review the Group's capital structure regularly.

LIQUIDITY AND FINANCIAL RESOURCES

As at 30 September 2023, the Group had cash and cash equivalents of approximately HK\$5.28 million (as at 30 September 2022: HK\$19.26 million). The current ratios (current asset divided by current liabilities) of the Group were approximately 1.09 times and 1.03 times as at 30 September 2023 and 30 September 2022, respectively.

The Directors are of the view that at the date of this quarterly report, the Group's financial resources are sufficient to support its business and operations.

As at 30 September 2023, the gearing ratio of the Group, (calculated by total bank borrowings less pledged bank deposits and cash and bank balances as a percentage of total equity) was approximately 378.21% (30 September 2022: 170.11%).

As at 30 September 2023, the Group had no capital commitments.

The Group's purchases are denominated in Hong Kong Dollars. The sales of the Group are predominantly in United States Dollars, Renminbi and Hong Kong Dollars. The Group will review and monitor from time to time the risk relating to foreign exchanges.

During the Period, the Group neither took part in any derivatives activities nor entered into any hedging activities in respect of foreign exchange risk.

CONTINGENT LIABILITIES

The Group had no material contingent liabilities as at 30 September 2023 (31 December 2022: Nil).

SHARE OPTION SCHEME

The Company has a share option scheme (the "Share Option Scheme") which was approved and adopted by the shareholders of the Company (the "Shareholder(s)") by way of written resolutions passed on 20 June 2018. The Share Option Scheme shall be valid and effective for a period of 10 years commencing on the date it was adopted. The purpose of the Share Option Scheme is to provide incentives or rewards to participants for their contribution to our Group and/or to enable our Group to recruit and retain high-calibre employees and attract human resources that are valuable to our Group and any entity in which our Group holds any equity interest ("Invested Entity").

Under the Scheme, the Board of Directors of the Company may grant options to eligible employees, including directors of the Company and its subsidiaries, to subscribe for shares in the Company. The total number of shares in respect of which options may be granted under the Scheme is not permitted to exceed 10% of the shares in issue at any point in time, without prior approval from the Company's shareholders. The Company may not grant any options if the number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Scheme and other schemes exceeds 30% of the Shares in issue from time to time. Options granted to the substantial shareholders or Independent Non-executive Directors of the Company in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5,000,000 must be approved in advance by the Company's shareholders. The option will be offered for acceptance for a period of not less than five trading days from the date on which the option is granted. Upon acceptance of the option, Directors and eligible employees of the Company shall pay HK\$1.00 to the Company by way of consideration for the grant.

Options may be exercised at any time from the date of grant of the share option to the tenth anniversary of the date of grant. The exercise price is determined by the Board of Directors of the Company, and will not be less than the highest of (i) the nominal value of the Company's share; (ii) the closing price of the Shares on the date of grant; and (iii) the average closing price of the Shares for the five business days immediately preceding the date of grant. No share options have been granted since the adoption of the Scheme on 28 June 2018.

COMPETITION AND CONFLICT OF INTERESTS

None of the Directors, the management shareholders or substantial shareholders of the Company or any of its respective associates has engaged in any business that competes or may compete, either directly or indirectly, with the businesses of the Group, as defined in the GEM Listing Rules, or has any other conflict of interests with the Group during the Period.

CORPORATE GOVERNANCE CODE

The Board is of the view that the Company has met the code provisions set out in the Corporate Governance Code (the "Corporate Governance Code") contained in Appendix 15 to the GEM Listing Rules throughout the Period, except for the deviation as specified and explained below with considered reasons for such deviations.

Provision C.2.1 of the Corporate Governance Code stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Cheuk Sin Cheong Clement is currently both the chairman of our Board and the chief executive officer of our Company. In view of the fact that Mr. Cheuk has been assuming the day-to-day responsibilities in operating and managing our Group since 1986 and the rapid development of our Group, the Board believes that with the support of Mr. Cheuk's extensive experience and knowledge in the business of the Group, vesting the roles of both the chairman of our Board and the chief executive officer of our Company in Mr. Cheuk strengthens the solid and consistent leadership and thereby allows for efficient business planning and decision which is in the best interest to our Group.

The Directors consider that the deviation from provision C.2.1 of the Corporate Governance Code is appropriate in such circumstances. Notwithstanding the above, the Board is of the view that this management structure is effective for our Group's operations, and sufficient checks and balances are in place.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Company had adopted a code of conduct regarding securities transactions by Directors on terms no less exacting than the required standard of dealings as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Having made specific enquiry, the Company confirms that the Directors have complied with required standard of dealings and its code of conduct regarding securities transactions by Directors throughout the Period.

AUDIT COMMITTEE

The Company established an audit committee (the "Audit Committee") on 20 June 2018 with written terms of reference in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules, and paragraph C.3 of the Corporate Governance Code. The members of the Audit Committee comprise Mr. Yu Sau Ning, Homer M.H., Mr. Zhao Zhipeng and Ms. Yee Wai Fong, Wendy. The chairperson of the Audit Committee is Mr. Yu Sau Ning, Homer M.H..

The primary duties of the Audit Committee are mainly to make recommendations to our Board on the appointment and removal of the external auditor, review the financial statements and related materials and provide advice in respect of the financial reporting process and oversee the internal control procedures of our Group.

The financial information in this quarterly report has not been audited by the auditor of the Company, but the Audit Committee has reviewed the unaudited consolidated results of the Group for the Period, which the Audit Committee was of the opinion that such results have been prepared in compliance with the applicable accounting standards and the GEM Listing Rules, and that adequate disclosures have been made.
