1. INTRODUCTION

The purpose of this circular is to provide you with information regarding: (i) the special resolution to be proposed at the EGM relating to the Proposed Change of Company Name; and (ii) the notice of the EGM.

2. PROPOSED CHANGE OF COMPANY NAME

Reference is made to the announcement of the Company dated 7 December 2023 in relation to the Proposed Change of Company Name. The Board proposes to change the English name of the Company from “Excalibur Global Financial Holdings Limited” to “Well Link Securities Holdings Limited” and to adopt the Chinese name “立橋證券控股有限公司” as the new dual foreign name of the Company in place of the existing Chinese name “駿溢環球金融控股有限公司”.

Conditions for the Proposed Change of Company Name

The Proposed Change of Company Name is subject to the following conditions:

- (i) the passing of a special resolution by the Shareholders at the EGM to approve the Proposed Change of Company Name; and
- (ii) the Registrar of Companies in Cayman Islands approving the Proposed Change of the Company Name.

Subject to the satisfaction of the conditions set out above, the Proposed Change of Company Name will take effect from the date the Registrar of Companies in Cayman Islands registers the proposed new English name in place of the existing English name of the Company and registers the proposed dual foreign name in Chinese of the Company as set out in the certificate of incorporation on change of name and the certificate of dual foreign name in Chinese to be issued by the Registrar of Companies in Cayman Islands. Thereafter, the Company will comply with the necessary filing procedures in Hong Kong.

Reasons for the Proposed Change of Company Name

Following the change of substantial shareholder of the Company on 16 November 2023, the Board considers the Proposed Change of Company Name will provide the Company with a more defined corporate image and identity which will benefit the Company’s future business development. The Board believes that the Proposed Change of Company Name is in the interests of the Company and the Shareholders as a whole.

Effect of the Proposed Change of Company Name

The Proposed Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company in issue bearing the existing name of the Company will, upon the Proposed Change of Company Name becoming effective, continue to be effective and as documents of title to the Shares and will remain valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the free exchange of the existing Share certificates for new Share certificates bearing the new name of the Company. Upon the Proposed Change of Company Name becoming effective, any new Share certificates will be issued under the new name of the Company.

The Company will make further announcement(s) on the Proposed Change of the Company Name and the effective dates of the Proposed Change of Company Name and the new stock short name of the Company under which the Shares will be traded on the Stock Exchange and the address of the new website of the Company as and when appropriate.

The Proposed Change of Company Name will not affect the Group's daily business operations and its financial position.

3. EGM

The EGM will be convened and held for the purposes of considering and, if thought fit, passing the relevant resolution to approve (i) the Proposed Change of Company Name.

Pursuant to Rule 17.47(4) of the GEM Listing Rules and the Articles of Association, any vote of Shareholders at a general meeting must be taken by poll save that the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. An announcement on the poll results will be published by the Company after the EGM in the manner prescribed under Rule 17.47(5) of the GEM Listing Rules.
