## Electronic Dissemination of Corporate Communications

- (2) to receive a printed notification letter of the publication of the Corporate Communications on the Websites.

The Company is making these arrangements with a view to increasing efficiency, cost-effectiveness and protecting the environment and accordingly recommends you to elect for the Email Option and provide a valid email address to the Company.

**If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by 15 March 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Share Registrar at the above address or by email to [8232-corpcomm@unionregistrars.com.hk](mailto:8232-corpcomm@unionregistrars.com.hk), to have elected to receive printed notification letter of the publication of the Corporate Communications. In future, when the Company publishes any Corporate Communication on the Websites, it will only send to you a notification that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a **valid** email address) or by post (if you have not provided an email address or the email address is **invalid**) at your address as it appears in the Company’s register of members maintained by the Hong Kong Share Registrar. It is your responsibility to provide an email address that is functional. The Company will be considered to have complied with the requirements of the GEM Listing Rules if it sends Corporate Communications to your email address without receiving any “non-delivery message”. To the extent permitted by the GEM Listing Rules, the Company will also send corporate communications that seek instructions from you on how you wish to exercise your rights or make elections as the Company’s shareholder (“Actionable Corporate Communications”) to you individually by email. If the Company does not possess your email address or the email address provided is not functional, the Company will send the Actionable Corporate Communications in printed form together with a request form for soliciting your functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.**
