PROPOSED CHANGE OF COMPANY NAME

The board ("Board") of directors (the "Directors") of Greatwalle Inc. (the "Company") proposed to change the English name of the Company from "Greatwalle Inc." to "Century Plaza Hotel Group" and to change the dual foreign name in Chinese of the Company from "長城匯理公司" to "新都酒店集團" (the "Proposed Change of Company Name").
