To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of that power of attorney or authority must be deposited with the Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours (i.e. 3:00 p.m. on Monday, 6 May 2024) before the time appointed for holding the AGM or any adjournment thereof and in default thereof this form of proxy shall not be treated as valid. No instrument appointing a proxy shall be valid after the expiry of 12 months from the date of its execution.

  8. A shareholder entitled to attend and vote at the AGM is entitled to appoint a person or persons (who must be individual) as his or her proxy or proxies to attend and, on a poll, vote instead of him or her. A proxy need not be a shareholder of the Company.

  9. Completion and delivery of this form of proxy will not preclude you from attending and voting in person at the AGM if you so wish.

  Full text of the resolutions is set out in the notice of AGM which is contained in the circular of the Company dated 5 April 2024 and despatched to the shareholders of the Company together with this form of proxy.

  This form of proxy is made in English and Chinese. In case of inconsistency, the English version shall prevail.
