Pursuant to the Placing Agreement, the Company has conditionally agreed to allot and issue, and the Placing Agent has conditionally agreed to place, on a best effort basis, up to 70,000,000 new Shares to not less than six Placees at the Placing Price of HK\$0.07 per Placing Share. The Placees and (where appropriate) their respective ultimate beneficial owner(s) shall be Independent Third Parties. The Placing Shares will be issued under the General Mandate.

The Placing Shares represent (i) approximately 7.37% of the existing issued share capital of the Company, and (ii) approximately 6.86% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares.

The Placing Agent has conditionally agreed to place, on a best effort basis, up to 70,000,000 new Shares to not less than six Placees at the Placing Price of HK\$0.07 per Placing Share.

The Placing Agent will receive a placing commission of 1.8%, on a successful basis, of the aggregate amount equal to the Placing Price multiplied by the Placing Shares successfully placed by the Placing Agent. Having considered the size and the terms of the Placing and the recent market sentiment, the Directors are of the view that the placing commission of 1.8% for the Placing is fair and reasonable.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Placing Agent and its ultimate beneficial owner(s) are Independent Third Parties.

#### **Placees**

# **Placing Price**

The Placing Price of HK\$0.07 per Placing Share represents:

- i. a discount of 13.58% to the closing price of HK\$0.081 per Share as quoted on the Stock Exchange on 16 April 2024, being the date of the Placing Agreement; and
- ii. a discount of approximately 16.27% to the average closing price of HK\$0.0836 per Share as quoted on the Stock Exchange for the five consecutive trading days of the Shares immediately prior to the date of the Placing Agreement.

The Placing Price was determined after arm's length negotiations between the Company and the Placing Agent with reference to, among other matters, the prevailing market price of the Shares and the recent market condition, historical and prevailing market prices of the Shares and liquidity of the Shares. The Directors consider that the terms of the Placing Agreement (including the Placing Price and the placing commission) are fair and reasonable based on the current market conditions and the Placing is in the interests of the Company and the Shareholders as a whole.

As at the date of this announcement, the General Mandate has been utilised to issue and allot a total of 100,000,000 new Shares under the placing of the Company completed on 18 January 2024 (the "January Placing"). After utilisation of a total of 100,000,000 Shares under the January Placing, a total of 70,000,000 Shares under the General Mandate remain unutilised. Accordingly, the allotment and issue of the Placing Shares is not subject to the approval of the Shareholders.

The 70,000,000 Placing Shares constitute 100% of the remaining General Mandate and, upon completion of the Placing, the General Mandate has been fully utilised.

#### CAPITAL-RAISING ACTIVITIES IN THE PAST TWELVE MONTHS

During the past 12 months, the Company undertook the January Placing under general mandate, which was completed on 18 January 2024, whereby the Company issued a total of 100,000,000 new Shares and the total gross proceeds and net proceeds (after deducting the placing fee and other related expenses) from January Placing are HK\$8.0 million and HK\$7.7 million, respectively. The Company intends to use the unutilised portion of the net proceeds of January Placing according to the intended use of proceeds as disclosed in the announcement of the Company dated 18 January 2024 in relation to the completion of January Placing. The unutilised portion of the net proceeds of January Placing is currently placed in banks in the PRC.

#### USE OF PROCEEDS FROM THE PLACING

The gross proceeds and the net proceeds (after deducting the placing fee and other related expenses incurred in the Placing) from the Placing are expected to be HK\$4.9 million and approximately HK\$4.7 million, respectively. The net proceeds raised per Placing Share is approximately HK\$0.067.

It is expected that (i) approximately HK\$3.0 million, representing approximately 63.82% of the net proceeds, will be used for developing online sales channels of the functional garment manufactured by the Group, which includes advertisement and production expenses of function garment manufactured by the Group, payment of cooperation fee, deposits and product listing fee to major e-commerce platforms in the PRC, hiring anchors (commonly known as "KOL") to promote function garments by hosting live-streaming direct online marketing sessions on online sales platforms and social media platforms, setting up live-

streaming broadcast room and acquiring relevant live-streaming equipment for promotion of function garments; and (ii) remaining balance of approximately HK\$1.7 million, representing approximately 36.17% of the net proceeds, will be used for general working capital of the Company.

### REASONS FOR THE PLACING

The Group is an established labelling solution provider and a one-stop garment accessories manufacturer and supplier based in the PRC. The Group mainly engages in the production of three types of products, which are (i) printed products (e.g. hangtags, price tags and stickers), (ii) woven labels (e.g. woven brand labels, woven size labels and badges) and (iii) printed labels (e.g. printed brand labels, printed size labels and care content labels). The Group also sources and sells other garment accessories, such as tapes, hanging tablets, string locks, leather badge, buttons and metal products, to its customers in the PRC.

As disclosed in the announcements dated 24 April 2020 and 3 December 2021 and the interim report of the Company for the six months ended 30 June 2023, given the economic downturn in the post-COVID-19 era, the continuous trade frictions between the PRC and the United States, which adversely affects the international trade of garment, keen competition from Southeast Asian countries and rising labour cost in the PRC, the Board considers it to be in the interest of the Company and its shareholders to diversify its business and look for new business opportunities.

As previously disclosed in the announcement for January Placing dated 2 January 2024, the Group has expanded its business into production and trading of functional garment in the PRC, which includes bed sheets, pillowcases and clothes, which employs mugwort (艾草) as part of the raw material in the fabrics, with mugwort believed to have the function of calming one's mind and enhancing blood circulation in Chinese medicine theory. While the Group manufactures products of functional garment with health emphasis, the Directors consider that it is imperative for the Group to also engage in business-to-consumer ("B-to-C") sales in order to increase brand and product awareness in the PRC market. The Directors considers it is an increasingly common trend for manufacturers in the PRC to directly engage in B-to-C sales by cooperating with e-commerce platforms and social media platforms to boost the sales amount and minimise the transaction and middleman costs. Therefore, the Directors consider engagement in B-to-C sales of the functional garment manufactured by the Group would assist the Group in increasing its revenue, which will be beneficial to the growth of the Group.

The Directors (including the independent non-executive Directors) consider that the terms of the Placing Agreement (including the placing commission) are fair and reasonable, on normal and commercial terms and the Placing is in the interest of the Company and the Shareholders as a whole.
