The total number of shares entitling the Shareholders to attend and abstain from voting in favour of any of the Resolutions at the AGM was nil. No Shareholder was required to abstain from voting on any of the Resolutions at the AGM. No Shareholders have stated in the Circular their intention to vote against the Resolutions at the AGM or to abstain from voting.

The AGM was chaired by Mr. Chong Siu Ning, an executive Director. The executive Directors, namely, Mr. Chong Siu Pui and Mr. Chong King Fan, and the independent non-executive Directors, namely, Mr. Wong Cho Kei Bonnie, Ms. Wong Pui Man and Mr. Wong Yau Sing, had also attended the AGM in person.

The branch share registrar and transfer office of the Company in Hong Kong, Tricor Investor Services Limited, acted as the scrutineer for the purpose of vote-taking at the AGM.
