6. This revised form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation or institution, either under the common seal or under the hand of any director or attorney duly authorized in writing.

To be valid, this revised form of proxy and, if such revised form of proxy is signed by a person under a power of attorney or other authority on behalf of the appointer, a nominally certified copy of that power of attorney or other authority, must be deposited at the Company’s H Share registrar, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, and in case of holders of Domestic Shares, to the Company’s mailing address at No. 27 Chaoqian Road, Science and Technology Industrial Park, Changping District, Beijing, the PRC, postal code 102200, attention to the secretary to the Board, as soon as possible and in any event not less than 24 hours before the time for holding the Meeting or appointed time of voting or any adjournment thereof.
8. A member entitled to attend and vote at the Meeting is entitled to appoint one or more proxies to attend and vote on his behalf. The proxy needs not be a member of the Company but must attend the Meeting in person to represent you.
9. In the case of the joint holders of any share, only the person whose name appears first in the register of members shall be entitled to attend and exercise all the voting powers attach to such share at the Meeting.
10. Any alteration made to this revised form of proxy must be initialled by the person(s) who sign(s) it.
11. If you wish to appoint a proxy to attend and vote at the Meeting on your behalf and if you have not yet returned the first proxy form issued on 6 June 2024 (the “**First Proxy Form**”) to the Company, you should complete, sign and return this revised form of proxy which contains the proposals in the supplemental notice of the Meeting issued on 18 June 2024 to Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong no later than 24 hours before the time appointed for holding the Meeting or any of its adjournments (as the case may be) (the “**Closing Time**”). In this case, the First Proxy Form should not be submitted to the Company.
12. If you wish to appoint a proxy to attend and vote at the Meeting on your behalf, and have already duly completed and submitted the First Proxy Form to the Company, you should note that: (a) if this revised form of proxy is not submitted, the First Proxy Form correctly completed and duly lodged will be treated as a valid proxy form submitted by you. The proxy so appointed shall be required to vote in such manner as he/she may be directed under the First Proxy Form and, in respect of the resolutions set out in the supplemental notice of the Meeting, the proxy will be entitled to vote at his/her discretion or to abstain from voting on such resolutions; (b) if this revised form of proxy is duly completed and submitted by the Closing Time, such revised form of proxy will supersede the First Proxy Form submitted by you. This revised form of proxy will be treated as a valid proxy form submitted by you; and (c) if this revised form of proxy is submitted after the Closing Time, such revised form of proxy will be invalid and the validity of the First Proxy Form correctly completed and duly submitted by you will not be affected. The proxy appointed by you under the First Proxy Form (if duly completed) will be entitled to vote in the manner as mentioned in (a), as if this revised form of proxy is not lodged.
