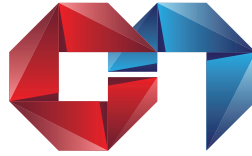

As at the date of the AGM, the total number of issued Shares was 510,793,747 Shares, which was the total number of Shares entitling the Shareholders to attend and vote on all the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend the AGM but abstain from voting in favour of any resolutions at the AGM as set out in Rule 17.47A of the GEM Listing Rules. No Shareholder was required under the GEM Listing Rules to abstain from voting on the resolutions at the AGM. None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM. Tricor Secretaries Limited, the Company's branch share registrar and transfer office in Hong Kong, had been appointed as the scrutineer for the vote-taking at the AGM.
