The Board is pleased to announce that all the resolutions proposed at the AGM were duly passed by way of poll at the AGM held on Friday, 28 June 2024.

Reference is made to the circular (the “**Circular**”) of SuperRobotics Holdings Limited (the “**Company**”) dated 31 May 2024 and all resolutions proposed in the notice (the “**Notice**”) of the annual general meeting of the Company (the “**AGM**”) contained therein. Unless stated otherwise, capitalised terms used herein shall have the same meanings as those defined in the Circular.

RESULTS OF ANNUAL GENERAL MEETING

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company is pleased to announce that all the resolutions proposed at the AGM were duly passed by way of poll at the AGM held on Friday, 28 June 2024.

The Company’s branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited, was appointed as the scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the total number of issued shares the (“**Shares**”) of the Company was 607,463,599 Shares, which was the total number of Shares entitling the shareholders of the Company (the “**Shareholders**”) to attend and vote for or against all the resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 17.47A of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and no Shareholders were required under the GEM Listing Rules to abstain from voting on the resolutions at the AGM. No person had indicated in the Circular of his intention to vote against or to abstain from voting on any of the resolutions at the AGM.

The AGM was chaired by Mr. Su Zhenhui, and all Directors attended the AGM either in person or by electronic means.
