Reference is made to the announcements (the “**Announcements**”) of Winto Group (Holdings) Limited (the “**Company**”) dated 31 May 2024 and 21 June 2024 in relation to the Placing. Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

### **COMPLETION OF THE PLACING**

The Board is pleased to announce that the Conditions have been fulfilled on 25 June 2024 and completion of the Placing took place on 28 June 2024. An aggregate of 124,416,000 Placing Shares, representing approximately 16.67% of the issued share capital of the Company immediately after completion of the Placing, have been successfully placed to not less than six Placees at the Placing Price of HK\$0.056 per Placing Share.

To the best of the Directors’ knowledge, information and belief, having made all reasonable enquiries, each of the Placees and where appropriate, their respective ultimate beneficial owners is an Independent Third Party, and none of the Placees has become a substantial Shareholder immediately upon completion of the Placing.

The net proceeds from the Placing, after deduction of all relevant expenses (including but not limited to placing commission, legal expenses and disbursements), are approximately HK\$6.48 million. The Company intends to use the net proceeds for expenditure for current business development of the Group.
