PROFIT WARNING

This announcement is made by Nexion Technologies Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2024 (the “**Period**”) and the information currently available, the Group is expected to record a loss attributable to equity holders of the Company of no more than approximately HK\$3,600,000, as compared to a loss attributable to equity holders of the Company of approximately HK\$3,902,000 for the six months ended 30 June 2023 (the “**Prior Period**”).

Based on the information currently available, the Board considered the expected decrease in loss was mainly attributable to the aggregate effect from (i) loss for the period from discontinued operation of the cyber infrastructure solutions business of approximately HK\$300,000 in the Period (*Prior Period: approximately HK\$1,775,000*) due to the completion of disposal of Netsis Technology (BVI) Limited on 29 February 2024 (the “**Completion**”). Upon the Completion, the Group has no longer engaged in the cyber infrastructure solutions business; (ii) change of segment results (adjusted earnings before interest, taxes, depreciation and amortization) (“**Adjusted EBITDA**”) from the cyber security solutions segment from profit of approximately HK\$875,000 for the Prior Period to loss of approximately HK\$74,000 for the Period, which was mainly due to the completion of projects with lower gross profit margin and employment of IT professionals with relatively higher remuneration package during the Period; and (iii) change of segment results (Adjusted EBITDA) from Software-as-a-Service segment from profit of approximately HK\$364,000 for the Prior Period to loss of approximately HK\$593,000 for the Period, which was mainly due to decrease in service fee charged to compete against the increase in market competition and increase in sales commission arising from introduction of new customers/projects to the Group.

The Company is still in the process of finalising the consolidated financial results of the Group for the Period. The information contained in this announcement is only based on the information currently available to the Company and such information has not been reviewed or audited by the independent auditor of the Company or reviewed by the audit committee of the Company.

Shareholders and potential investors are advised to peruse the financial results of the Company for the Period with care when it is released. The interim results of the Group for the Period shall prevail over the information contained herein. It is expected that the interim results of the Group for the Period will be published on 16 August 2024.

Shareholders and potential investors should exercise caution when dealing in the securities of the Company.
