POSITIVE PROFIT ALERT

This announcement is made by Hyfusin Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review by the Board of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2024 (“**1stH2024**”) and the information currently available to the Board, the Group expected to record a profit attributable to owners of the Company in the range of approximately HK\$94.0 million to HK\$96.0 million for the 1stH2024 as compared with that of approximately HK\$59.5 million for the six months ended 30 June 2023.

The Board considers that the above expected increase in profit attributable to owners of the Company was primarily due to (i) the increase in revenue resulted from the new orders from customers; (ii) the increase in gross profit margin benefiting from the decrease in cost of raw materials of the Group; and (iii) a reversal of provision of the claim for the recall of approximately HK\$29.7 million.

The Group is still in the process of finalising its interim results for the 1stH2024. The information in this announcement is only based on the preliminary review of the unaudited consolidated management accounts of the Group for the 1stH2024 and the information currently available to the Board, and hence may or may not be accurate. The unaudited consolidated management accounts of the Group for the 1stH2024 have not yet been finalised nor reviewed by the audit committee of the Company. The interim results of the Group for the 1stH2024 may be different to the information referred in this announcement. Shareholders and potential investors are advised to read carefully the interim results announcement of the Company for the 1stH2024, which is expected to be published on 16 August 2024 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
