### **CLARIFICATION ANNOUNCEMENT**

Reference is made to the announcement of the Prime Intelligence Solutions Group Limited (the “**Company**”) dated 1 November 2021 (the “**Announcement**”). As disclosed in the Announcement, the Company was in talks with Lanzhu Technology (Chongqing) Company Limited\* (懶豬科技(重慶)有限公司) (“**Chongqing Lazy Pig**”) in respect of possible collaborations to explore smart technology-related business opportunities in the PRC. The Company wishes to clarify that no formal collaboration has ever been established between the Company and Chongqing Lazy Pig as at the date of this announcement and the Company does not intend to pursue any such collaborations in the future.

Furthermore, it has come to the attention of the Company that Chongqing Lazy Pig has engaged in various promotional activities such as press conferences, ceremonies and announcements of contract signings. Moreover, it appears to the Company that certain companies, such as Chongqing Lanzhu Network Technology Company Limited\* (重慶懶豬網絡技術有限公司), Beixiaoji (Chongqing) Digital Technology Company Limited\* (貝小集(重慶)數字科技有限公司), Chongqing Xinhecong Network Technology Company Limited\* (重慶新合叢網絡科技有限公司), Chongqing Dehou Yifeng Information Technology Partnership (Limited Partnership)\* (重慶德厚益豐信息科技合夥企業(有限合夥)), Jianling (Chongqing) Commercial Management Company Limited\* (建瓴(重慶)商業管理有限公司) and Puhui Space (Chongqing) Technology Company Limited\* (普惠空間(重慶)科技有限公司) (together with Chongqing Lazy Pig, the “**PRC Companies**”) and Gexu (Hong Kong) Company Limited (格旭(香港)有限公司) (previously known as Lazy Pig Technology (Hong Kong) Company Limited (懶豬科技(香港)有限公司)) (the “**Hong Kong Company**”) are purportedly affiliated with Chongqing Lazy Pig. Considering the similarities in names between some of the PRC Companies, the Hong Kong Company and the Company, the Company wishes to clarify that (i) none of the PRC Companies and the Hong Kong Company are subsidiaries or associated companies of the Company; (ii) the Company has no affiliations with any of the PRC Companies or the Hong Kong Company; and (iii) the Company does not have any business relationships or arrangements with any of the PRC Companies or the Hong Kong Company.

Additionally, the Company would like to take this opportunity to clarify that (i) Lazy Pig Holdings Limited (懶豬控股有限公司), which is a Hong Kong incorporated company, is not a subsidiary or associated company of the Company; (ii) the Company has no affiliations with this Hong Kong company; and (iii) the Company does not have any business relationships or arrangements with this Hong Kong company.
