On 12 February 2025 (after trading hours), the Company and the Placing Agent entered into the Placing Agreement pursuant to which the Company appointed the Placing Agent to place, on a best-effort basis and subject to the fulfillment of the condition precedent to the Placing, a maximum of 126,720,000 Placing Shares to not less than six independent Placees at a price of HK\$0.1 per Placing Share.

The Placing Price of HK\$0.1 per Placing Share represents: (i) a discount of approximately 5.0% to the closing price of HK\$0.105 per Share as quoted on the Stock Exchange on the date of the Placing Agreement; (ii) a premium of approximately 19.9% to the average closing price of HK\$0.0834 per Share as quoted on the Stock Exchange for the last five trading days of the Shares immediately prior to the date of the Placing Agreement; and (iii) the par value of a Placing Share.

Assuming the Placing Shares are fully placed, the maximum number of 126,720,000 Placing Shares represents 20.00% of the issued share capital of the Company of 633,600,000 Shares as at the date of this announcement, and approximately 16.67% of the issued share capital of the Company as enlarged by the issue of the maximum number of 126,720,000 Placing Shares.

Assuming the Placing Shares are fully placed, the gross and net proceeds from the Placing will be HK\$12,672,000 and approximately HK\$12,300,000, respectively. The Company intends to apply approximately 40% of the net proceeds, in the approximate amount of HK\$5,000,000, for the manufacturing and sale of plastic product in Vietnam and approximately 60% of the net proceeds, in the approximate amount of HK\$7,300,000, for general working capital of the Group.

The Placing is not subject to the Shareholders' approval as the Placing Shares will be issued pursuant to the General Mandate.

Shareholders and potential investors of the Shares should note that the completion of the Placing is subject to the fulfillment of the conditions precedent as set out in the Placing Agreement and the Placing may or may not proceed. Shareholders and potential investors are advised to exercise caution when dealing in the Shares.

As at the date of this announcement, the Placing Agent is an associate of the Company.

Placees

It is intended that the Placing Shares will be placed to not less than six Placees, being individuals, corporate, institutional investors or other investors, who and whose ultimate beneficial owners are Independent Third Parties.

It is expected that none of the Placees nor their associates will become a substantial shareholder of the Company as a result of the Placing.

Number of Placing Shares

The Company appointed the Placing Agent to place, on a best-effort basis and subject to the fulfillment of the condition precedent to the Placing, a maximum of 126,720,000 Placing Shares. Assuming the Placing Shares are fully placed, the maximum number of 126,720,000 Placing Shares represents 20.00% of the issued share capital of the Company of 633,600,000 Shares as at the date of this announcement, and approximately 16.67% of the issued share capital of the Company as enlarged by the issue of the maximum number of 126,720,000 Placing Shares. The aggregate nominal value of the maximum number of Placing Shares is HK\$12,672,000.

Placing Price

The Placing Price of HK\$0.1 per Placing Share was agreed after arm's length negotiations between the Company and the Placing Agent with reference to the recent trading price of the Shares and the par value of a Placing Share.

The Placing Price of HK\$0.1 per Placing Share represents: (i) a discount of approximately 5.0% to the closing price of HK\$0.105 per Share as quoted on the Stock Exchange on the date of the Placing Agreement; (ii) a premium of approximately 19.9% to the average closing price of HK\$0.0834 per Share as quoted on the Stock Exchange for the last five trading days of the Shares immediately prior to the date of the Placing Agreement; and (iii) the par value of a Placing Share.

Placing Commission

The Company shall pay to the Placing Agent the placing commission of 1% of the aggregate Placing Price of the total number of the Placing Shares actually placed on behalf of the Company by the Placing Agent in pursuance of its obligations under the Placing Agreement.

Condition of the Placing

Completion of the Placing is conditional upon the Stock Exchange granting or agreeing to grant listing of and permission to deal in the Placing Shares.

If the above condition is not satisfied on or before the Long Stop Date, the Placing will lapse and all rights, obligations and liabilities of the Placing Agent and the Company in relation to the Placing shall cease and terminate and neither party shall have any claim against the other in respect of the Placing save for any antecedent breach and/or any rights or obligations which may accrue under the Placing Agreement prior to such termination. The condition to the Placing could not be waived by any party to the Placing Agreement.

Completion of the Placing

Completion of the Placing shall take place within five business days after the fulfillment of the condition of the Placing (or such other date as the Company and the Placing Agent may agree).

Rescission of the Placing Agreement

If any of the following events occur at any time prior to 10:00 a.m. on the Completion Date, the Placing Agent may (after such consultation with the Company and/or its advisers as the circumstances shall admit or be necessary), by giving a written notice to the Company, at any time prior to the Completion Date provided that such notice is received prior to 6:00 p.m. on the day immediately preceding the Completion Date, rescind the Placing Agreement without

liability to the other party, and the Placing Agreement shall thereupon cease to have effect and none of the parties shall have any rights or claims by reason thereof save for any rights or obligations which may accrue under the Placing Agreement prior to such termination:

- (i) in the reasonable opinion of the Placing Agent there shall have been since the date of the Placing Agreement such a change in national or international financial, political or economic conditions or taxation or exchange controls as would be likely to prejudice materially the consummation of the Placing; or
- (ii) the introduction of any new law or regulation or any change in existing law or regulation (or the judicial interpretation thereof) or other occurrence of any matter whatsoever which may adversely affect the business or the financial or trading position or prospects of the Group as a whole; or
- (iii) any material breach of any of the representations and warranties set out in the Placing Agreement comes to the knowledge of the Placing Agent or any event occurs or any matter arises on or after the date of the Placing Agreement and prior to the Completion Date which if it had occurred or arisen before the date of the Placing Agreement would have rendered any of the representations and warranties contained in the Placing Agreement untrue or incorrect in any material respect or there has been a material breach by the Company of any other provision of the Placing Agreement; or
- (iv) any moratorium, suspension or restriction on trading in shares or securities generally on the Stock Exchange due to exceptional financial circumstances; or
- (v) there is any adverse change in the financial position of the Company which in the reasonable opinion of the Placing Agent is material in the context of the Placing.

Ranking of Placing Shares

The Placing Shares, when issued and fully paid, will rank pari passu among themselves and with Shares in issue at the time of issue and allotment of the Placing Shares.

Application for listing

Application will be made to the Stock Exchange for approval for the listing of and permission to deal in the Placing Shares.

GENERAL MANDATE

The Placing is not subject to the Shareholders' approval as the Placing Shares will be issued under the General Mandate, which was granted to the Directors pursuant to an ordinary resolution passed by the Shareholders at the annual general meeting of the Company held on 7 June 2024. Pursuant to the General Mandate, the Company was authorized to issue and allot up to 126,720,000 Shares, representing 20% of the number of Shares in issue on the date of passing such resolution. As at the date of this announcement, the Company has not issued any Shares under the General Mandate. Accordingly, the General Mandate is sufficient for the allotment and issue of the Placing Shares.

REASONS FOR THE PLACING AND USE OF PROCEEDS

The Company is an investment holding company and the Group is principally engaged in providing international freight forwarding and logistics services, with a primary focus on air/sea freight forwarding and related services, trucking and warehousing to customers worldwide, manufacturing and sale of plastic products in Vietnam and trading of used mobile phones.

The Company strives to operate and develop its business to create value for the Company and its shareholders in a long term and sustainable manner, especially in the current uncertain market.

The manufacturing and sale of plastic product of the Company in Vietnam has shown encouraging results for the six months ended 30 June 2024. Based on the unaudited results of the Group for the six months ended 30 June 2024, the revenue of the business segment increased by approximately 40%, in the approximate amount of RM3,632,000 (equivalent to approximately HK\$6,327,526), as compared to the six months ended 30 June 2023.

Assuming the Placing Shares are fully placed, the gross and net proceeds from the Placing will be HK\$12,672,000 and approximately HK\$12,300,000, respectively. In view of the performance of the Company's manufacturing and sale of plastic product business segment, the Company intends to apply approximately 40% of the net proceeds, in the approximate amount of HK\$5,000,000, to strengthen its resources for the business segment and approximately 60% of the net proceeds, in the approximate amount of HK\$7,300,000, for general working capital of the Group.

The Board also considers that the Placing represents a good opportunity for the Company to raise additional funds and to widen the Company's shareholder base. The terms of the Placing Agreement (including the Placing Price and the placing commission) were determined after arm's length negotiations between the Company and the Placing Agent. The Directors (including the independent non-executive Directors) consider that the terms of the Placing Agreement (including the Placing Price and the placing commission) are on normal commercial terms, fair and reasonable and in the interests of the Company and the Shareholders as a whole.

Assuming the Placing Shares are fully placed, the net placing price will be approximately HK\$0.097 per Placing Share.

EQUITY FUND RAISING ACTIVITY DURING THE PAST TWELVE MONTHS

The Company has not conducted any equity fund raising activities in the past 12 months immediately preceding the date of this announcement.
