This announcement is made by Sunray Engineering Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the information currently available to the Board and a preliminary review of the unaudited consolidated management accounts of the Group for the year ended 31 March 2025 (“**FY2025**”), the Group expects to record a net loss of not more than HK\$13.5 million for FY2025 as compared to that of approximately HK\$0.8 million for the year ended 31 March 2024.

The expected net loss for FY2025 is primarily due to (i) the provision for impairment on trade receivables and contract assets (including retention receivables) in the range of HK\$12.5 million to HK\$13.5 million, which is associated with a debtor facing financial difficulties and becoming probable for default on payment; and (ii) the increase in selling and distribution costs arising from the increase in warehouse and storage costs.

The Company is still in the process of finalising its annual results for FY2025. The information contained in this announcement is only based on the preliminary assessment made by the Board on the unaudited consolidated management accounts of the Group for FY2025 with reference to the information currently available, and such information has not been reviewed by the Company's auditors or the audit committee of the Company and may be subject to adjustments where necessary. Shareholders and potential investors are advised to peruse with care the annual results announcement of the Company for FY2025, which is expected to be released on 27 June 2025.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
