This announcement is made by Century Energy International Holdings Limited (the “**Company**”, collectively with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 16 June 2025 (the “**Announcement**”), in relation to the meeting of the board (the “**Board**”) of directors (the “**Director(s)**”) of the Company originally scheduled to be held on Monday, 30 June 2025 for the purpose of, inter alia, considering and approving the annual results of the Group for the year ended 31 March 2025 (the “**2025 Annual Results**”) and its publication.

DELAY IN PUBLICATION OF THE 2025 ANNUAL RESULTS

The Board wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that there will be a delay in the publication of the 2025 Annual Results as additional time is required for completing certain audit procedure including collecting the external confirmations and certain supporting documents on the impairment assessment of inventory and other receivables.

Pursuant to Rule 18.49 of the GEM Listing Rules, the Company is required to publish an announcement in relation to its 2025 Annual Results not later than three months after the date upon which the financial year of the Company ended (i.e. on or before 30 June 2025). Though the delay in publication of the 2025 Annual Results would constitute non-compliance of Rule 18.49 of the GEM Listing Rules, the Board wishes to emphasize that the operations of the Group remain normal, and the Company will use its best endeavour to publish the 2025 Annual Results as soon as possible. The Board is working closely with the auditor of the Company, Confucius International CPA Limited (the “**Auditor**”), and has

been using its best endeavours to assist and cooperate in order to complete the auditing process as soon as possible. Based on the recent communications with the Auditor, the Company expects that the 2025 Annual Results will be published on or before 31 July 2025.

The Company will publish further announcement(s) in due course to inform the Shareholders of (i) the date of the meeting of the Board to consider and approve the 2025 Annual Results; (ii) the date of the release of the 2025 Annual Results; and (iii) any material development.

POSTPONEMENT OF BOARD MEETING

As disclosed in the Announcement, the Board meeting is to be held on 30 June 2025 for the purposes of, among other things, considering and approving the 2025 Annual Results and considering the recommendation of a final dividend, if any.

Due to the aforesaid delay in the publication of the 2025 Annual Results, the Board meeting will be postponed. The Company will publish further announcement to inform the Shareholders of the date of the Board meeting as and when appropriate.

SUSPENSION OF TRADING

Pursuant to Rule 17.49A of the GEM Listing Rules, the Stock Exchange will normally require suspension of trading in an issuer's securities if an issuer does not publish its financial information in accordance with the GEM Listing Rules. The suspension will normally remain in force until the issuer publishes an announcement containing the requisite financial information. Trading in the shares of the Company on the Stock Exchange is expected to be suspended with effect from 9:00 a.m. on 2 July 2025, pending the publication of the 2025 Annual Results.

Further announcement will be made by the Company as and when appropriate in accordance with the GEM Listing Rules.

Save as disclosed above, there is no other inside information that has led to the delay in the publication of the 2025 Annual Results. Further announcement(s) will be published by the Company to inform the Shareholders and its potential investors of any material development on the aforesaid matters in due course.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
