FINANCE LEASE AGREEMENT WITH FUJIAN XINGCHENG

On 10 September 2025 (after market close), the Purchaser entered into a sale-leaseback transaction with Fujian Xingcheng under the Finance Lease Agreement. Pursuant to the Finance Lease Agreement, the Purchaser has agreed to purchase from Fujian Xingcheng the Leaseback Assets at the Consideration of RMB21,000,000 (equivalent to approximately HK\$23,046,240), and lease to Fujian Xingcheng the Leaseback Assets for a term of 36 months in return for the Lease Payments.

IMPLICATIONS UNDER THE GEM LISTING RULES

As one or more of the applicable percentage ratios (as defined in the GEM Listing Rules) in respect of the transaction contemplated under the Finance Lease Agreement exceeds 5% but is less than 25%, such transaction constitutes a discloseable transaction of the Company under Chapter 19 of the GEM Listing Rules and is subject to the notification and announcement requirements under Chapter 19 of the GEM Listing Rules.

INTRODUCTION

On 10 September 2025 (after market close), the Purchaser entered into a sale-leaseback transaction with Fujian Xingcheng under the Finance Lease Agreement. Pursuant to the Finance Lease Agreement, the Purchaser has agreed to purchase from Fujian Xingcheng the Leaseback Assets at the Consideration of RMB21,000,000 (equivalent to approximately HK\$23,046,240), and lease to Fujian Xingcheng the Leaseback Assets for a term of 36 months in return for the Lease Payments.

FINANCE LEASE AGREEMENT

The principal terms and conditions of the Finance Lease Agreement are summarised as follows:

Date: 10 September 2025

Parties: (1) The Purchaser (the lessor)

(2) Fujian Xingcheng (the lessee)

The Leaseback Assets are 4 automatic screen printers (自動 Assets acquired: 絲印機), 2 vacuum laminators (真空壓合機), 6 sets of UV-

LED semi-automatic PCB exposure machine (UV-LED半自 動線路曝光機), and 7 fully automatic printing presses (全自

動印刷機).

Consideration: The Consideration for the purchase of the Leaseback

Assets is RMB21,000,000 (equivalent to approximately

HK\$23,046,240).

The Consideration payable by the Purchaser was based on the original purchase prices payable by Fujian Xingcheng for the purchase of the Leaseback Assets as evidenced by the official documents issued by Hanjiang District Finance Bureau of Putian City (莆田市涵江區財政局). In determining the amount of the Consideration, the Purchaser has made reference to the original purchase prices of the

Leaseback Assets, and determined the amount through arm's length negotiation with Fujian Xingcheng.

Payment of Consideration: Subject to the fulfilment of certain conditions, including,

among others, the receipt by the Purchaser from Fujian Xingcheng of (i) a complete set of documents or documentary proof relating to the ownership of the equipment and any other documents requested by the Purchaser; (ii) evidence of due payments of management fee, security deposit and other fees under the Finance Lease Agreement; and (iii) Fujian Xingcheng's declaration that it has legal ownership over the Leaseback Assets and that no encumbrance has been created in respect thereof, the Purchaser shall pay to Fujian Xingcheng the Consideration within 7 business days after the

fulfilment of the aforesaid conditions.

The Consideration will be financed by the Group's internal

resources and bank borrowings.

Ownership of the Leaseback The Purchaser will be entitled to the Leaseback Assets upon

the signing of the Finance Lease Agreement.

The Leaseback Assets shall be leased by the Purchaser to

Fujian Xingcheng for a term of 36 months commencing from

11 September 2025.

Assets:

Lease Payments:

The aggregate Lease Payments for the entire three-year lease term is RMB23,308,152 (equivalent to approximately HK\$25,579,298).

The Lease Payments shall be payable by Fujian Xingcheng by 12 quarterly instalments commencing from 11 December 2025. Each quarterly instalment shall be RMB1,942,346 (equivalent to approximately HK\$2,131,608).

The aggregate Lease Payments for the entire three-year lease term was based on the Consideration plus the total amount of interest agreed to be charged by the Purchaser to Fujian Xingcheng for the entire lease term.

The effective annual interest rate for the sale-leaseback transaction under the Finance Lease Agreement is 6.56% per annum. The interest rate was determined by the Purchaser and Fujian Xingcheng through arm's length negotiation, and in determining the interest rate, the Purchaser has taken into account the prevailing bank lending rate, creditability of Fujian Xingcheng with reference to its credit track record, as well as the interest rate payable by companies comparable to Fujian Xingcheng.

Security deposit:

A security deposit of RMB1,050,000 (equivalent to approximately HK\$1,152,312) shall be payable by Fujian Xingcheng to secure the performance of its obligations under the Finance Lease Agreement. In addition, the Purchaser may (i) apply the security deposit to settle the final outstanding amount of the Lease Payments; or (ii) pay it back to Fujian Xingcheng without interest after Fujian Xingcheng has fully discharged its payment obligation under the Finance Lease Agreement; or (iii) apply the security deposit to offset the amount of consideration for the early buyback of the Leaseback Assets by Fujian Xingcheng provided that Fujian Xingcheng has fulfilled its obligations under the Finance Lease Agreement and there is no default on the part of Fujian Xingcheng (or has there been any default, such default has been cured and the liquidated damages have been duly paid).

Liquidated damages:

If Fujian Xingcheng fails to pay any amount of the Lease Payments due or any other amount payable under the Finance Lease Agreement, Fujian Xingcheng shall pay liquidated damages from the payment due date, which is equivalent to the product of (i) the amount of late payment; (ii) a daily default rate of 0.05%; and (iii) the number of days from the payment due date to the full settlement date.

Retention consideration:

Subject to the fulfilment of all of Fujian Xingcheng's obligations under the Finance Lease Agreement and the payment of the last instalment for the Lease Payments, Fujian Xingcheng may repurchase the Leaseback Assets from the Purchaser upon the retention payment at the consideration of RMB100 (equivalent to approximately HK\$110).

Early buyback by Fujian Xingcheng:

The Purchaser has agreed that Fujian Xingcheng may repurchase the Leaseback Assets before the date on which the final instalment shall be payable, provided that (i) there is no default on the part of Fujian Xingcheng (or has there been any default, such default has been cured and the liquidated damages have been duly paid); (ii) Fujian Xingcheng gives the Purchaser a 30-day prior written notice of the proposed early buyback; and (iii) the Purchaser has consented in writing to the proposed buyback by Fujian Xingcheng.

The Purchaser has agreed to transfer the ownership of the Leaseback Assets to Fujian Xingcheng, provided that Fujian Xingcheng has paid to the Purchaser in full the following sums as of the date of purchase to be agreed among the parties: (i) all the payments of liquidated damages and the lease payment for the month in which the early buyback takes place; (ii) the outstanding principal to be paid; (iii) the compensation payment representing 1% of the outstanding principal; and (iv) the retention consideration of RMB100 (equivalent to approximately HK\$110).

Events of default:

The Purchaser may take one or more of the following measures: (i) terminate the Finance Lease Agreement, take possession and dispose of the Leaseback Assets and claim against Fujian Xingcheng for damages; (ii) declare that the outstanding Lease Payments, other amounts payable by Fujian Xingcheng and the liquidated damages shall be immediately payable by Fujian Xingcheng; (iii) claim against Fujian Xingcheng any fee arising as a result of enforcing or defending the Purchaser's rights under the Finance Lease Agreement; and (iv) seek other relief as permitted by the law, upon the occurrence of certain triggering events, including, among others, failure to pay on time any instalment of the Lease Payments or any other amount payable by Fujian Xingcheng in full or the failure of Fujian Xingcheng to perform any other duties and obligations under the Finance Lease Agreement and such failure has not been cured within 7 days after the written notification from the Purchaser to Fujian Xingcheng.

REASONS FOR AND BENEFITS OF THE TRANSACTION

The Purchaser is primarily engaged in finance leasing business in the PRC. It is expected that the Finance Lease Agreement will enable the Group to earn an aggregate income of approximately RMB2,308,252 (equivalent to approximately HK\$2,533,168) over the three-year lease term.

Given that the Finance Lease Agreement was entered into in the ordinary and usual course of business of the Purchaser and was agreed between the Purchaser and Fujian Xingcheng on normal commercial terms, the Directors are of the view that the terms of the Finance Lease Agreement are fair and reasonable and are in the interests of the Group and the Shareholders as a whole.

INFORMATION ON THE CREDIT ASSESSMENT IN RESPECT OF THE FINANCE LEASE AGREEMENT

The entering into of the Finance Lease Agreement was determined on the basis of the Company's credit assessment made on, inter alia, the financial strength and the background of Fujian Xingcheng. The Company has prepared the due diligence report to evaluate the creditworthiness of Fujian Xingcheng, which provides an important reference for its credit risk management. In preparing such report, the Company has analysed the balance sheet, profit and loss statement and cash flow statement of Fujian Xingcheng, and the biographical information of its ultimate beneficial owner. Fujian Xingcheng has good reputation, and proven track records. Based on the credit assessment, the Company considers that the credit risk relating to entering into the Finance Lease Agreement is relatively low.

The Board (including the independent non-executive Directors) is of the view that the Finance Lease Agreement: (i) is entered into in the ordinary and usual course of business of the Group; (ii) is on normal commercial terms; and (iii) is on terms that are fair and reasonable and in the interests of the Company and its Shareholders as a whole; and that the consideration under the Finance Lease Agreement is fair and reasonable and in the interests of the Company and its Shareholders as a whole.

INFORMATION ABOUT THE GROUP

The Group is primarily engaged in the provision of (i) financial services including equipment-based financing solutions, and financial information service to customers, and (ii) packaging and paper products trading.

INFORMATION ABOUT THE PURCHASER

The Purchaser is a company established in the PRC and principally engaged in finance leasing business in the PRC.

Fujian Xingcheng is a wholly-owned subsidiary of Putian High-tech Industrial Park Development Co., Ltd.* (莆田市高新技術產業園開發有限公司). Putian High-tech Industrial Park Development Co., Ltd. is 51% owned by the Hanjiang District Finance Bureau of Putian City (莆田市涵江區財政局) and 49% owned by Putian Hanjiang Xinghua Bay Port Development Co., Ltd.* (莆田市涵江區興化灣港口開發有限公司), in turns which is indirectly wholly owned by Putian Province State-owned Assets Administration Commission (莆田市國有資產管理委員會).
