Reference is made to the announcement of the Well Link Securities Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 22 October 2025 in relation to the continuing connected transactions in relation to the brokerage services provided by the Group (the “**Announcement**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the Announcement.

This announcement is made to provide the supplemental information on the identities of the ultimate beneficial owners of Banco Well Link. As at the date of the Announcement, to the best of Directors’ knowledge, information and belief having made all reasonable enquiry, Banco Well Link has a diverse shareholder base and is held as to (i) approximately 60% by Well Link Holdings, its single largest shareholder, which is held as to 97% by Mr. Xu Chujia; (ii) 15% by Kingyin (Macau) Holdings Limited; (iii) 10% by Shengman Investments Limited; and (iv) certain shareholders with less than 10% shareholding. Other than Mr. Xu Chujia as disclosed above, there is no natural person who control, directly or indirectly, one-third or more of Banco Well Link.

Save as disclosed above, all other information and content set out in the Announcement remain unchanged. This supplemental announcement is supplemental to and should be read in conjunction with the Announcement.
