REDUCTION OF LOSS
ESTIMATED INTERIM RESULTS FOR
THE SIX MONTHS ENDED 30 SEPTEMBER 2025

This announcement is made by OOH Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform shareholders of the Company (“**Shareholders**”) and potential investors that based on the latest review of the unaudited management accounts (the “**Latest Management Accounts**”) of the Group for the six months period ended 30 September 2025 (“**6M2026**”), the Group is expected to record a net loss of approximately HK\$1.7 million for 6M2026 as compared to a net loss of approximately HK\$5.3 million for the six months period ended 30 September 2024 (“**6M2025**”). The expected decrease in loss for 6M2026 was mainly attributable to (i) increase in revenue; and (ii) decrease in depreciation related to the impaired right-of-use assets of approximately HK\$2.4 million.

The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the Latest Management Accounts and the information currently available to the Company. Such information has not been reviewed or confirmed by the auditor or the audit committee of the Company. Further details of the Group’s performance will be disclosed in the interim results announcement of the Company for 6M2026, which is expected to be published on 27 November 2025.
