INSIDE INFORMATION CHANGE OF SUBSTANTIAL SHAREHOLDER

This announcement is made by China Saftower International Holding Group Limited (the “**Company**” and together with its subsidiaries as the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) of Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The Company was informed by Red Fly Investment Limited (the “**Vendor**”), a substantial shareholder of the Company, on 30 December 2025 (after trading hours) that it has disposed of a total of 46,790,000 shares of the Company (the “**Shares**”), representing approximately 25.00% of the issued Shares as at the date of this announcement, to Lockxy Investment Limited (the “**Purchaser**”), a company incorporated in the British Virgin Islands with limited liability (the “**Transfer**”).

The Purchaser is an investment holding company and is wholly owned by Ms. Luo Xi (M. Luo). As at the date of this announcement, Ms Luo is the executive director of the Company.

Immediately after completion of the Transfer, (a) the Vendor has remined 5,902,000 Shares, representing approximately 3.15% of the issued Shares and has ceased to be a substantial shareholder (as defined in the Listing Rules) of the Company; and (b) the Purchaser and Ms. Luo have become interested in 47,958,500 Shares, representing approximately 25.62% of the issued Shares as at the date of this announcement, and has become a substantial shareholder (as defined in the Listing Rules) of the Company.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Shares.
