VOLUNTARY ANNOUNCEMENT

COMPLETION OF TRADING TOKENISED INVESTMENTS AT ESPERANZA'S SECONDARY MARKET AND SUBSCRIPTION OF TWO TOKENISED INVESTMENTS RELATING TO KOREAN BOYBAND CONCERTS

This announcement is made by Hatcher Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis. The purpose of this announcement is to keep the shareholders of the Company (the “**Shareholders**”) and potential investors informed of the latest business development of the Group.

TRADING OF TOKENISED INVESTMENTS IN SECONDARY MARKET

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the Shareholders and potential investors that the Group has completed the purchase and sale of tokenised investments relating to Chris Wong 40th Anniversary Hong Kong Concert 2026 with a profit, which is managed by Esperanza Fintech (Securities) Limited (“**Esperanza**”). The trading of tokenised investments was conducted through the over-the-counter secondary market trading platform (“**Espetopia Platform**”) operated by Esperanza.

Espetopia Platform operates 24 hours a day, seven days a week, with active market for purchase and sale of tokenised investment products managed by Esperanza. It is a securities services offered by Esperanza, a corporation licensed by the Securities and Futures Commission in Hong Kong, with the permission to conduct securities tokenisation business activity granted on 13 February 2026.

The Board considers the success of tokenised investment trading a remarkable milestone to financial industry reform, proving the true commercialization and integration of traditional economy and technology. To the best knowledge of the Board, Esperanza is a leading regulated tokenised investments issuer and trading platform service provider with successful secondary market trading records in Hong Kong and Asia Pacific.

SUBSCRIPTION OF TOKENISED INVESTMENTS

The success of tokenised investment trading by the Group at Espetopia Platform represents a natural progression of strategic partnership with Esperanza to act as broker, distributor, underwriter and project financial advisor for future tokenised investments. To strengthen the Group's financial performance and experience, the Group will subscribe to two tokenised investments managed by Esperanza in March 2026, involving investments of:

1. K-Sarang Super Concert in Malaysia, starring Cho Kyuhyun of Super Junior and AHOF, a Korean boy band formed through SBS TV's reality competition show Universe League. The concert will be shown on 11 April 2026 at The Arch Galleries, Kuala Lumpur. In August 2025, AHOF's first fan concert in the Philippines were sold out in 30 minutes.
2. 2026 CNBlue Live World Tour '3logy' in Bangkok, starring CNBlue Korean pop rock band, will be shown on 6 June 2026 at Thunder Dome Muang Thong Thani, Bangkok ("**CNBlue Bangkok**"). The previous show in Taipei on 6 March 2026 was sold out. The organizer added an additional show on 7 March 2026. According to Thaiticketmajor, the official ticketing platform of CNBlue Bangkok, the highest price standing areas and certain seated areas are sold out. As of 12 March 2026, approximately less than 430 seats (out of approximately 4,000 seats) are available for purchase.

The Group will subscribe the entire available tokenised investments at initial subscription by its own internal resources and is expected to resell the tokenised investments at Espetopia Platform or hold the investments until maturity for profit.

The Group is in the process of reaching out its business beyond offering, inter alia, traditional corporate finance advisory services, business consulting services, ESG advisory services, and risk management and internal control advisory services, to include regulated blockchain securities with corporate finance elements. This further subscription and trading of tokenised investments strengthen the track record of the Group in establishing an automated trading platform for tokenised investments with the group of Esperanza.
