PROFIT WARNING

This announcement is made by Hyfusin Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review by the Board of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (“**Yr2025**”) and the information currently available to the Board, the Group expected to record a profit attributable to owners of the Company in the range of approximately HK\$99.0 million to HK\$103.0 million for the Yr2025 as compared with that of approximately HK\$171.4 million for the year ended 31 December 2024.

The Board considers that the above expected decrease in profit attributable to owners of the Company was primarily due to the decrease in gross profit margin resulting from the decrease in selling price of products and the increase in cost of production of the Group and the absence of a reversal of provision of the claim for the recall of approximately HK\$29.7 million recorded in the year ended 31 December 2024.

The Group is still in the process of finalising its annual results for the Yr2025. The information in this announcement is only based on the preliminary review of the unaudited consolidated management accounts of the Group for the Yr2025 and the information currently available to the Board, and hence may or may not be accurate. The unaudited consolidated management accounts of the Group for the Yr2025 have not yet been finalised nor reviewed by the audit committee of the Company. The annual results of the Group for the Yr2025 may be different to the information referred in this announcement. Shareholders and potential investors are advised to read carefully the annual results announcement of the Company for the Yr2025, which is expected to be published on 25 March 2026 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
