BUSINESS UPDATE ON TOKENISED INVESTMENTS

UPDATE ON SUBSCRIPTION OF TOKENISED INVESTMENT RELATING TO CNBLUE BANGKOK

The Board is pleased to provide an update that, following the subscription, the Group is in the process of planning a series of investor engagement activities, such as roadshows, in relation to this investment in CNBlue Bangkok and is working with Esperanza to promote its market presence. These initiatives are aimed at enhancing market awareness and understanding of the tokenised investment product, as well as the underlying event, i.e. CNBlue Bangkok.

NEW SUBSCRIPTION OF TOKENISED INVESTMENT RELATING TO A HONG KONG THEATRE

The Board further announces that the Group is in the negotiation process for the subscription of a new tokenised investment managed by Esperanza, which relates to a theatre performance co-produced with a leading film enterprise in Asia and expected to be staged in Hong Kong during the period from July to August 2026.

This further subscription of tokenised investment strengthens the track record of the Group in tokenised investments. The Group intends to subscribe the entire available tokenised investment of the abovementioned project at initial subscription by its own internal resources and expects to realise the tokenised investments at Espetopia Platform or hold the investments until maturity for profit, subject to the market conditions.
