1) In the extraordinary general meeting (the "EGM") held on 14 May 2026, it was approved that the authorised share capital of the Company increased from HK\$10,000,000 divided into 1,000,000,000 shares with a par value of HK\$0.01 each to HK\$20,000,000 divided into 2,000,000,000 shares with a par value of HK\$0.01 each by creating an additional 1,000,000,000 unissued shares with a par value of HK\$0.01 each.

2) In the EGM, the share consolidation on the basis of every ten (10) issued and unissued ordinary shares of HK\$0.01 each in the share capital of the Company be consolidated into one (1) ordinary share of HK\$0.10 each (the "Share Consolidation") was approved. Following the Share Consolidation becoming effective on 18 May 2026, the authorised share capital of the Company shall be adjusted to HK\$20,000,000 divided into 200,000,000 shares with a par value of HK\$0.10 each.
