PROFIT ALERT — REDUCTION OF LOSS

This announcement is made by Zhonghua Gas Holdings Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of the Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company wishes to inform the shareholders and potential investors of the Company that, based on the information currently available to the Board and the preliminary review of the relevant unaudited consolidated management accounts of the Group for the year ended 31 March 2026 (the “**Current Year**”), the Group is expected to record an decrease in net loss after tax by 56.4% from approximately RMB60.0 million for the fifteen months ended 31 March 2025 (the “**Previous Period**”) to approximately RMB26.2 million for the Current Year. Such decrease in net loss after tax was mainly attributable to (i) no equity-settled share-based expense was recorded in the Current Year (Previous Period: approximately RMB26.9 million); (ii) a decrease of finance costs from approximately RMB9.9 million for the Previous Period to finance income of approximately RMB1.7 million in the Current Year; and (iii) a decrease in administrative expense due to fifteen months results was recognised in the Previous Period and twelve months results was recognised in the Current Year.

The decrease in net loss after tax was set-off by a decrease in reversal of impairment allowance on trade receivables and contract assets from approximately RMB4.2 million for the Previous Period to impairment allowance on trade receivables and contract assets of approximately RMB15.3 million for the Current Year.

As the Company is still in the course of preparing the audited consolidated financial results of the Group for the Current Year, the information contained in this announcement is only based on a preliminary assessment by the Board with reference to the unaudited consolidated management accounts of the Group for the Current Year and the information currently available to the Board as at the date hereof. The unaudited consolidated management accounts of the Group for the Current Year and such information have neither been confirmed nor audited by the auditors of the Company or the audit committee of the Company and may be subject to amendments. Shareholders and potential investors of the Company are advised to read carefully the final results announcement of the Company for the Current Year when it is published in accordance with the GEM Listing Rules.
