The board (the “**Board**”) of directors (the “**Directors**”) of China Oral Industry Group Holdings Limited (the “**Company**”) announces that at the annual general meeting of the Company held at 2/F., No. 81, Qianshan Industrial Zone, Qianshan Village, Xiangzhi Town, Shishi City, Quanzhou, Fujian Province, China at 9:41 a.m. on Monday, 15 June 2026 (the “**AGM**”), save and except for the resolution numbered 2(a)(ii) regarding the re-election of Ms. Deng Xin, all the proposed resolutions (the “**Resolutions**”) as set out in circular (the “**Circular**”) incorporating a notice of the AGM dated 30 April 2026 (the “**AGM Notice**”) were duly passed as ordinary resolutions by the shareholders of the Company (the “**Shareholders**”) by way of poll. Unless otherwise defined, terms used herein shall have the same meanings as defined in the Circular.

- (b) As more than 50% of the votes were cast in favour of each of the ordinary resolutions nos. 1, 2(a)(i), 2(a)(iii), 2(b), 3 to 6, all such ordinary resolutions were duly passed. As less than 50% of the votes were cast in favour of the proposed resolution no. 2(a)(ii), such resolution was not passed as an ordinary resolution.
- (c) The total number of shares in issue as at the date of the AGM was 1,641,417,722 Shares.
- (d) The total number of shares entitling the holders to attend and vote on the Resolutions at the AGM was 1,641,417,722 Shares.
- (e) The total number of shares entitling the holders to attend and abstain from voting in favour of the Resolutions at the AGM (as set out in Rule 17.47A of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”)): Nil.

- (g) None of the Shareholders have stated their intention in the Circular to vote against or to abstain from voting on any of the Resolutions at the AGM.

Save for Ms. Lian Jingyu and Ms Tseung Choi Wing Queenie who was not able to attend the AGM due to other work reasons, all other Directors attended the AGM in person or by electronic means.

The Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited, acted as the scrutineer for the purpose of vote taking at the AGM.

RETIREMENT OF DIRECTOR AND CHANGE IN COMPOSITION OF BOARD COMMITTEES

As indicated above, the resolution numbered 2(a)(ii) regarding the re-election of Ms. Deng Xin ("**Ms. Deng**") as an independent non-executive Director was not passed at the AGM. Accordingly, Ms. Deng has retired as an independent non-executive Director, with effect from the conclusion of the AGM on 15 June 2026.

Immediately following the retirement of Ms. Deng as an independent non-executive Director, Ms. Deng ceased to be a member of the audit committee of the Company and the chairman of the remuneration committee (the "**Remuneration Committee**") of the Company. Mr. Geng Chuan Long has been appointed as the chairman of Remuneration Committee with effect from 15 June 2026.

The Board would like to express its sincere gratitude to Ms. Deng for her contribution to the Company during her term of office with the Company.
