POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 14 SEPTEMBER 2026

Reference is made to the circular of Zhejiang United Investment Holdings Group Limited (the “**Company**”) dated 19 August 2026 (the “**Circular**”) setting out, inter alia, the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) of the Company held on 14 September 2026. Capitalised terms used herein have the same meanings as those defined in the Circular unless the context requires otherwise.

The Board is pleased to announce that at the AGM held on 14 September 2026, all the proposed resolutions set out in the Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, a total of 1,577,200,000 Shares were in issue. None of the Shareholders were required to abstain from voting at the AGM under the GEM Listing Rules. In addition, there were no Shares entitling the Shareholders to attend and abstain from voting in favour of any resolution at the AGM as set out in Rules 17.47A of the GEM Listing Rules.

All Directors of the Company attended the AGM either in person or by electronic means. Union Registrars Limited, the share registrar of the Company in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of the vote-taking.
