He has held executive and advisory posts in various charitable institutions. He is Chairman of both the Chou's Foundation and the Winsor Education Foundation set up with the object of promoting and sponsoring the advancement of education, and have provided assistance to many local students to further their studies. Mr. Chou is also the President of The Hong Kong Association of Health Care Limited, a non-profit making institution aiming at the promotion of medical and health care knowledge amongst the general public. Mr. Chou is a brother of Mr. Chow Chung Kai.

Mr. Chow has over 40 years of experience in the textile, clothing and property businesses. He has played an active role in various trade associations and has also served as member of the Cotton Advisory Board, the Textile Advisory Board, the Industry Advisory Board, the Hong Kong Export Credit Insurance Corporation Advisory Board, and the Securities Commission. He is a brother of Mr. Chou Wen Hsien and the father of Mr. Chow Wai Wai, John.

Mr. CHOW Wai Wai, John, aged 52, Deputy Managing Director, joined the Group in 1979 and was appointed Director of the Company in September 1985. He graduated with a Bachelor of Arts (Economics) degree from the University of British Columbia.
