### **PURCHASE, SALE OR REDEMPTION OF THE COMPANY'S LISTED SECURITIES**

For the six months ended 31st July, 2002, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the Company's listed securities.

### **DIRECTORS' INTERESTS IN SHARES**

At 31st July, 2002, Mr. Lee Teh Yee, William personally had beneficial interests in 33,000 shares of the Company. In addition, Mr. Lee Teh Yee, William, through two private companies controlled by him, was also beneficially interested in 25,000 ordinary shares in Modern Aspac Development Company Limited ("Modern Aspac"), representing 50% of its issued share capital. Modern Aspac is a 50% owned associate of the Group which beneficially held 533,400 shares of the Company.

Save as disclosed herein and except for shares in subsidiaries held by directors in trust for their immediate holding companies, at 31st July, 2002, none of the directors nor their associates had any interests in any securities of the Company or any of its associated corporations as defined in the Securities (Disclosure of Interests) Ordinance, and none of the directors nor their spouses or children under the age of 18 had any right to subscribe for the securities of the Company, or had exercised any such right during the period.

### **SUBSTANTIAL SHAREHOLDERS**

Save as disclosed in the section "Directors' Interests in Shares", at no time during the period has the Company been notified of any other interests representing 10% or more in the issued share capital of the Company pursuant to section 16(1) of the SDI Ordinance.
