Final Dividend

The board recommends the payment of a final dividend of 0.555 US cents per share in respect of the year ended 31 December 2003. Subject to shareholders' approval, the final dividend will be paid in cash to shareholders whose names appear on the register of members of the Company on 17 May 2004.

Dividend warrants will be despatched to shareholders on or about 1 June 2004.

The register of members will be closed from 18 May 2004 to 21 May 2004, both dates inclusive. In order to qualify for the proposed final dividend, all completed transfer forms accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrars not later than 4:00 p.m. on 17 May 2004.
