Report of the Directors

董事會報告

The Board present their first report and the audited financial statements of the Company and the Group for the year ended 31 December 2003.

Reorganisation

The Company was incorporated in the PRC as a joint stock limited company on 27 September 2001. In preparing for the listing of the Company's H Shares on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), the Company has undertaken a series of reorganisations (the "Reorganisation"). Details of the Reorganisation are set out in the section entitled "Corporate Reorganisation" in Appendix VII to the Prospectus.

The Company's H Shares were listed on the Stock Exchange on 6 February 2004.

Principal Activities

The principal activities of the Group are the development and sale of high quality private residential properties in the PRC, mainly in Shanghai, as well as other ancillary property related services. There were no significant changes in the nature of the Group's principal activities during the year.

Results and Dividends

The Group's profit for the Year and the state of affairs of the Company and the Group as at 31 December 2003 are set out in the financial statements on pages 68 to 128.

No payment of final dividend pertaining to the Year was recommended by the Directors. In addition, the Board recommended that the distributable reserves of the Company as at 31 December 2003 were retained for appropriation in the future and the holders of Domestic Shares and H Shares are entitled to the same rights to the distributable reserves of the Company as at 31 December 2003.
