Prior to joining DVN, he was Senior Assistant to the President, and General Manager of the R&D Center of China Aerospace International Holdings with an overall responsibility for technology and marketing strategy development. Mr. Lui has received numerous technology awards including the Best Design of Consumer Product by the Hong Kong government in 1998. He is a key member of China's Digital Broadcasting Transmission Standards Committee

Mr. Lui holds a bachelor's and a master's degree in electrical and electronics engineering from Zhejiang University and an MBA degree from the Chinese University of Hong Kong.

Susanna Chiu Lai Kuen *Senior Vice President - Business Development & Corporate Affairs*

Ms. Susanna Chiu Lai Kuen is responsible for business development and operations. Before joining DVN, Ms. Chiu worked for Caltex where she was directly responsible for setting up the infrastructure of their Greater China operations. Ms. Chiu brings considerable expertise in information technology and media.

Her achievements include conducting a review of the computerised financial system of the European Space Agency in Paris, Germany and Holland, and was involved in establishing a Chinese Satellite Broadcasting TV Station for Western Europe.

Ms. Chiu holds a MBA degree and graduated with Class 1 Honors. She is also a qualified Chartered Accountant, a China CPA and a Certified Information Systems Auditor. Ms. Chiu was awarded one of the ten nationwide "Chinese Women of Achievement" award in the UK in 1991. She is currently a council member on the Hong Kong Society of Accountants and the Hong Kong Chinese Orchestra, and is the President of the Information Systems Audit and Controls Association (HK Chapter).

Sam Wong *Senior Vice President - Finance*

Mr. Sam Wong has over 12 years of experience in investment banking, in both corporate finance and equity research. At Bear Stearns, he was involved in financing some of the first Chinese companies to list outside of China as well as helping take one of Thailand leading telecommunications companies public.

He also served as head of China research at Credit Suisse First Boston, spearheading the company's first efforts in China. Mr. Wong graduated with a B.A. in the Geophysical Sciences from the University of Chicago and a MBA from the Yale School of Management.

Li Jian Hua *Chief Technology Officer*

Mr Li Jian Hua is responsible for DVN's product engineering and research and development. Mr Li has over 13 years of work experience in research and development for digital cable and telecommunications. Mr Li previously worked for over eight years at the DSP Center of the Chinese Academy of Science in China, where he was responsible for developing the latest digital, consumer electronics and communications technology.

Mr. Li has developed two projects that have been approved as key projects for China's '863 Hi-Tech State Plan'. In 1996, he developed the 'Full Services Multimedia System'. In 2002, a second approved project was the 'HFC Multi-Services Operating Network'. The latter was developed in cooperation with DVN, and installed at the Suzhou CATV Station.

Mr Li is also one of the pioneers in China responsible for the development of the broadband IP city based network. He also won an award in 1999 – the "Qiu Shi Excellent Youth Prize" by the China Association for Science and Technology, and a special award in 2002 from the State Council for his outstanding contribution to China's national scientific and technological development.

趙麗娟 高級副總裁 - 業務發展及總部事務

趙麗娟女士負責公司的業務發展及營運工作。在加盟天地數碼前，她曾效力加德士集團，直接負責為該公司大中華業務建立基礎建設，在資訊科技和傳媒工作方面充分發揮專業知識。

趙女士曾參與分別在巴黎、德國和荷蘭進行的歐洲太空總署電腦化財務系統評估工作，並參與建造全西歐首個以衛星廣播的華人電視，成績斐然。

趙女士以一級榮譽畢業，持有工商管理碩士學位，並考獲英國特許會計師，中國註冊會計師及國際認可資訊系統審計師的專業資格。在一九九一年，她在英國獲頒殊榮，成為全英十大「傑出華裔女性」之一。趙女士現為香港會計師公會及香港中樂團的理事，及現任國際資訊系統審計協會香港分會會長。

黃植良先生擁有超過十二年投資銀行經驗，包括企業財務及證券研究的經驗。

在鄧白氏公司效力期間，黃先生有份參與為首批在中國境外上市的中資公司安排融資，並協助泰國一家具領導地位的電訊公司上市。

此外，他亦曾出任瑞士信貸第一波士頓中國研究部主管，對該公司發展中國業務作出貢獻。黃先生在美國芝加哥大學畢業，獲得地球物理科學學士學位，並獲耶魯大學管理學院工商管理碩士學位。

李建華先生負責本公司的技術開發及產品工程化管理。李先生在數碼及通訊技術上有超過13年的豐富工作經驗。

李先生曾在中科院數字信號處理中心（DSP中心）任職超過八年發展國際上通訊及最新技術。一九九六年向國家863申請重大項目「全業務網多媒體系統」，並獲批准。之後再次承擔863重大項目「HFC多功能業務運營示範網」，和天地數碼合作在蘇州有線電視台建立了中國第一個商業運營網絡，於二零零一年在蘇州通過國家驗收。

李先生也是在國內其中之一先驅率先提出利用寬帶IP網絡技術實施城域網。李先生曾在一九九九年獲中國科協求是傑出青年獎及在二零零二年獲頒國務院特殊貢獻獎。
