In the case of joint registered holders, the vote of the senior who tenders a vote at the meeting whether in person or by proxy will be accepted to the exclusion of the votes of the other joint holders. For this purpose, seniority is determined by the order in which the name stand in the Registers of Members in respect of the joint holding.

In order to be valid, this proxy form, together with any power of attorney or other authority (if any) under which it is signed, or a notarially certified copy thereof must be lodged with the principal office of the Company at Unit B10, 3/F., Merit Industrial Centre, 94 Tokwawan Road, Kowloon, Hong Kong as soon as possible and in any event not less than 48 hours before the time fixed for holding the meeting or any adjourned meeting thereof (as the case may be).
- Any member of the Company entitled to attend and vote at the above meeting is entitled to
 appoint one or more proxy(ies) to attend and vote instead of him. A proxy need not be a
 member of the Company but must attend the meeting in person to represent you. Each
 proxy form shall be for one anonitment only.
- Any alterations made in this proxy form must be initialled by the person who signs it.
