As at 30 June 2004, 97,041,333 shares are held by Optimist International Limited ("Optimist"), a wholly-owned subsidiary of Medusa Group Limited ("Medusa"). Medusa is beneficially owned by Messrs. Lam Kwok Yan and Lam Kwok Hing ("Messrs. Lam") equally and as such each is entitled to exercise or control the exercise of one-third or more of voting rights at general meeting of Optimist. Accordingly, under SFO, Messrs. Lam are each deemed to be interested in all the 97,041,333 shares of the Company held by Optimist.

The HK\$30 million zero coupon convertible note due 2006 was held by Karfun Investments Ltd ("Karfun"), which is a corporation controlled by Mr. Lam Kwok Hing. This interest in the underlying shares has also been disclosed under the section heading "Substantial Shareholders' Interests" below.

On 29 July 2004, Karfun has converted the HK\$30 million convertible note into 150,000,000 shares of HK\$0.01 each in the Company at a conversion price of HK\$0.20 per share, representing about 35.17% of the enlarged issued share capital of the Company.
