If you wish to appoint some person other than the Chairman of the Meeting as your proxy, please delete the words "the Chairman of the special general meeting of the Company or" and insert the name and address of the proxy desired in the space provided
- d. If you wish to vote for the resolutions set out above, please tick ("\(\sigma "\)) the box marked "For". If you wish to vote against the resolutions, please tick ("\(\sigma "\)) the box marked "Against". If the form returned is duly signed but without direction, the proxy will vote or abstain at his sole discretion. A proxy will also be entitled to vote at his discretion on any resolution properly put to the Meeting other than those set out in the notice convening the Meeting.
- e. In the case of a joint holder, this form of proxy must be signed by all joint holders, but if more than one joint holder is present at the Meeting, whether in person or by proxy, that one of the joint holders whose name stands first on the register of members in respect of the relevant joint holding shall alone be entitled to vote in respect thereof.
- f. This form of proxy must be signed by a shareholder, or his attorney duly authorised in writing, or if the shareholder is a corporation, either under its Common Seal or under the hand of an officer or attorney so authorised.
- g. To be valid, this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a certified copy of such power or authority must be deposited at the Company's principal place of business in Hong Kong at 4/F, Kenning Industrial Building, 19 Wang Hoi Road, Kowloon Bay, Kowloon, Hong Kong not less than 48 hours before the time fixed for holding the Meeting or any adjournment thereof.
- h. Any alteration made to this form should be initialled by the person who signs the form.
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the Meeting if you so wish. If you attend and
