This announcement is made by People's Food Holdings Limited (the "Company") in relation to notice dated 24 June 2005 of change in the interest of a substantial shareholder (namely FMR Corp. on behalf of the managed accounts of its direct and indirect subsidiaries and Fidelity International Limited on behalf of its direct and indirect subsidiaries) in the Company pursuant to the Companies Act, Chapter 50 of Singapore (the "Singapore Companies Act"). For the avoidance doubt, notices of substantial shareholding filed pursuant to the Singapore Companies Act are separate from those filed in accordance with Part XV of the Securities and Futures Ordinance, Chapter 571 of the Laws of Hong Kong (the "SFO").

Pursuant to section 83 of the Singapore Companies Act, where there is a change in the percentage level of the interest or interests of a substantial shareholder in a company in voting shares in a company listed on the Singapore Exchange Securities Trading Limited, the substantial shareholder is required to submit to the relevant listed company a notice in respect of such interest (including such details as, inter alia, name, address, the date of change of interest and the circumstances leading to that change). Pursuant to Rule 704(3) of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Company must make an announcement immediately upon receipt of such notification of change in substantial shareholder's interest in the Company. This announcement is made by the Company pursuant to rule 13.09(2) of the Listing Rules and contains a reproduction of the announcement made by the Company in Singapore pursuant to Rule 704(3) of the Listing Manual of the Singapore Exchange Securities Trading Limited. This announcement is simultaneously announced by the Company in Singapore and in Hong Kong on 27 June 2005.
