## Corporate Profile

## 公司概况

China-Hongkong Photo Products Holdings Limited (Stock Code: 1123) has a solid business partnership with Fujifilm Japan as the sole authorized distributor of Fujifilm products in Hong Kong and Macau since 1968, and in China since 1980.

The Group has established an extensive network of importers and distributors in mainland China, and distributors in Hong Kong and Macau. In July 2001, the Group acquired Fotomax Holdings Limited and extended its network from the wholesale to the retail level. Fotomax is a leading operator of retail chain stores that provide photographic processing services in Hong Kong.

In addition to photographic products, the Group distributes information systems products, medical imaging systems and graphic arts products. In May 2002, the Group was appointed as the authorized distributor of Fuji graphic arts products in Hong Kong and mainland China. In April 2003, it established a subsidiary, Fuji Medical Products Limited to plan the strategic development for a full line of medical products and services in Hong Kong, China and Macau, and in February 2005, a new joint venture company, Fujifilm Medical Systems (Shanghai) Co., Ltd. was jointly established with Fujifilm Japan to meet the rising demand for imported medical equipment and related products in China.

In China, the Group operates two joint venture companies in Beijing and Zhuhai, and two wholly-owned enterprises in Hainan and Sichuan. It also has representative offices in Guangzhou, Shanghai, Beijing and Chengdu. These provide the infrastructure to support the growth of the distribution network through training, coordination and marketing.

China-Hongkong Photo Products Holdings Limited was incorporated in Bermuda on 6 July 1994 and listed on the Stock Exchange of Hong Kong on 19 September 1994. The Group is held by the public (38.8%) and by its founder, the Sun family (61.2%) through Searich Group Limited, Fine Products Limited and Dago Corporation.

中港照相器材集團有限公司(股份代號:1123)與日本富士保持穩固而持久的商業夥伴關係,自1968年以來一直為日本富士在香港及澳門的唯一認可經銷商,並自1980年起將業務擴展至中國大陸。

集團在中國大陸、香港及澳門建立了廣泛的進口商和經銷商網絡。2001年7月,集團購入快圖美控股有限公司, 將分銷網絡的業務擴展至零售層面。快圖美是目前香港最具規模的影像服務連鎖店。

除分銷照相器材外,集團還兼售儲存媒體產品、醫療影像系統和印刷器材。2002年5月,集團獲授予富士印刷器材在中國大陸及香港的分銷權。2003年4月,集團成立了新附屬公司富士醫療產品有限公司,專責開拓及策劃全線醫療產品及服務在中港澳三地的策略發展。2005年2月更與日本富士一起合作成立了合營公司 — 富士醫療器材(上海)有限公司,以配合中國大陸對入口醫療設備及相關產品的增長需求。

在中國,集團分別在北京、珠海設有兩間合營公司以及在海南和四川開設兩間獨資公司,並在廣州、上海、北京及成都設立代表辦事處。這些企業提供培訓、協調及市場推廣服務,是支持集團在中國擴展分銷網絡的基石。

中港照相器材集團有限公司於1994年7月6日在百慕達註冊成立,並於同年9月19日在香港聯合交易所上市。集團百分之38.8%股權由公眾持有,而其餘61.2%則由創辦人孫氏家族透過Searich Group Limited,Fine Products Limited 及 Dago Corporation所擁有。
