- (a) On 3 December 2004, the Board of Directors of the Company passed an ordinary resolution to change the financial year end date of the Company from 31 December to 30 June, commencing from the year 2004. The reason for the change is to align the financial year end date of the Company with that of its ultimate holding company, Hong Leong Company (Malaysia) Berhad. As a result, the current financial period covers the period from 1 January 2004 to 30 June 2005.
- (b) The effect of adopting SSAP 12 (revised) had been adjusted to the opening balances of deferred taxation, interest in a jointly controlled entity, revenue reserve and minority interests as at 1 January 2002 and 1 January 2003, the results and movements in exchange reserve for the year ended 31 December 2002. No restatement of other comparative information had been made as the amounts related to prior years could not be reasonably determined.
