2005 was still a challenging year to Kwang Sung. The economic environment remained unfavourable to electronic component manufacturers worldwide and we were inevitably affected. We have to face the continued rise in raw material price and manufacturing costs that posed huge pressure on our gross margins, especially in the first half of the year. To combat the difficult operating environment, the Group invested tremendous effort to improve operational efficiency and its research and development functions. In spite of the tough business environment, with all these measures in place and economies in the region recovering, I am delighted to report that the Group's performance picked up in the second half of the year and I am confident that this growth momentum will continue in 2006.

Radio and multimedia broadcasting are set to enter a new era with Digital Audio Broadcasting ("DAB") and Digital Multimedia Broadcasting ("DMB") technology becoming prevalent. In addition to their initial application in some European and Asian countries, DAB and DMB are going to bring new audio and visual experiences to consumers across the world. As one of the first mover in the industry, we focused on the research and development of digital modules over the past years and have successfully received initial orders for them during the year under review. In 2006, we will step up effort in this area, which will allow us to seize arising opportunities in the market.

The future of the Group is certainly open for improvement with the economy and consumption sentiment in markets worldwide recovering. As an upstream supplier in the supply chain, we will benefit from the boom in demand of end-product manufacturers. Kwang Sung will, in the year ahead, seek to fortifying its research and development functions with the aims of improving existing products and widening its product mix to include new digital multimedia tuner modules as a critical category.

Finally, I would like to extend my thanks to the management, our staff and shareholders for their unswerving effort and commitment. With your support, I am confident our business teams will remain as the driving force behind our growth and pave the way for a brighter future for the Group.


