Mr Li Ka Fai David, aged 51, is currently the deputy managing partner of Li, Tang, Chen & Co. and a part-time instructor in the School of Continuing Studies, The Chinese University of Hong Kong. He is also a fellow of the Hong Kong Institute of Certified Public Accountants and The Association of Chartered Certified Accountants, UK as well as The Institute of Chartered Secretaries & Administrators, UK and an associate of The Institute of Chartered Accountants in England & Wales. He is an independent director of China Vanke Company Limited. He was awarded the Medal of Honour (MH) from The Government of the Hong Kong Special Administrative Region in July 2004.

**Dr Wong Chi Yun Allan**, JP, aged 55, is Chairman & Group Chief Executive Officer of VTech Holdings Limited. Dr Wong holds a Bachelor of Science degree in Electrical Engineering from the University of Hong Kong, a Master of Science degree in Electrical and Computer Engineering from the University of Wisconsin, USA and an honorary degree of Doctor of Technology from the Hong Kong Polytechnic University. Dr Wong is the Chairman of the Hong Kong Applied Science and Technology Research Institute and ex-officio member of the Steering Committe on Innovation and Technology. He is also a council member of the University of Hong Kong and an independent non-executive director of the Bank of East Asia Limited and Li & Fung Limited.

#### Non-executive Directors

**Ms Chiang Yun Rachel**, aged 38, is the Managing Director of ARC Capital Partners Ltd., which manages funds investing in consumer and retail sectors in Asia. Prior to that, Ms Chiang was the Vice President of AIG Global Investment Corporation (Asia) Ltd. Ms Chiang holds a Bachelor of Science degree from the Virginia Polytechnic Institute and State University, USA and a Master of Business Administration degree from the Kellogg Graduate School of Management at the Northwestern University, USA.

**Mr Liu Hui Allan**, aged 49, is the president and board member of The China Retail Fund LDC, an international direct investment fund sponsored by American International Group ("AIG") in cooperation with the former Ministry of Internal Trade ("MOIT") of the People's Republic of China ("PRC"). The fund invests in retail and retail related distribution business in the PRC with proven international retailers and distribution companies.

Prior to initiating and raising the fund, Mr Liu had had 14 years of experience in advising and assisting multinational corporations' entries into Mainland China. From the early 1980s, after receiving education in the UK, he had served as an official or an advisor to several PRC ministries. During 1984-1987, Mr Liu served as Deputy Director of Ministry of Foreign Trade & Economic Corporation's Center ("MOFTEC") for Market and Trade Development, one of the first ministerial organisations established to advise and assist foreign investors in PRC, and which was involved in attracting over US\$1 billion of direct foreign investments. From 1987, Mr Liu founded and served as President of the New York based China United Resources Corporation, on behalf of MOFTEC, engaging in consulting and direct investment services for major US corporations investing in Mainland China.
