Vision Century, a company incorporated in the British Virgin Islands and ultimately owned by a discretionary trust of which Mr. Wilson Ng and Mr. Ng Wee Keat are discretionary beneficiaries, is deemed to have interest in 231,645,000 shares of the Company comprising of 51,157,196 shares and 180,487,804 underlying shares to be issued on assumption that the convertible note of HK\$37,000,000 as at 30 September 2006 will be converted into shares of the Company at a conversion price of HK\$0.205 per share. Subsequent to the balance sheet date, the conversion price of the convertible note was adjusted from HK\$0.205 per share to HK\$0.141 per share as a result of the open offer as set out in note 20. Accordingly, the number of ordinary shares to be issued upon full conversion of the convertible note will be 262,411,347 shares.
- 2. Each of personal interests of Mr. Lo Ming Chi, Charles, Mr. Yu Wai Man, Mr. Wilson Ng, Mr. Ng Wee Keat and Mr. Ng Eng Leng are 800,000 underlying shares in respect of share options granted by the Company. Subsequent to the balance sheet date, each of the number of share options granted to Mr. Lo Ming Chi, Charles, Mr. Yu Wai Man, Mr. Wilson Ng, Mr. Ng Wee Keat and Mr. Ng Eng Leng has been adjusted from 800,000 to 1,024,000 as a result of the open offer as set out in note 20.
