Announcement

China Netcom (Group) Company Limited, a wholly owned subsidiary of China Netcom Group Corporation (Hong Kong) Limited (the "Company"), has completed the issue of the first tranche of commercial paper of an amount of RMB10 billion for the year 2007.

The Board of Directors of China Netcom (Group) Company Limited, a wholly owned subsidiary of the Company, passed a resolution on 15 May 2006 approving its offering of commercial paper with the outstanding amount not exceeding RMB20 billion (the "CP").

On 14 July 2006, China Netcom (Group) Company Limited obtained an approval for filing from the People's Bank of China with regard to its offering of the CP and, on 20 July 2006, completed the offering of the first tranche of the CP for the year 2006.

On 30 April 2007, China Netcom (Group) Company Limited completed the offering of the first tranche of the CP for the year 2007. The first tranche of the CP for the year 2007, with a maturity period of 365 days, was issued for the aggregate amount of RMB10 billion at an interest rate of 3.34% and with interests accruing from 10 May 2007.
